SCOPE OF WORK: The work to be performed under this Contract is for the construction of a sediment control facility in Laughlin, Nevada. The work will generally consist of flood control improvements consisting of excavation of a sediment basin, energy dissipation devices, concrete channel lining, storm drain facilities, and maintenance access; traffic control, dust control, and storm water pollution control; appurtenances and miscellaneous improvements as shown on the drawings; and other related items of work as specified and shown on the drawings.

ESTIMATED COST: \$1,604,455 - \$1,773,345.
