SCOPE OF WORK: The work to be performed under this Contract shall consist of furnishing all labor, materials, transportation and services for the construction of "Rainbow Boulevard – Blue Diamond Road to CC 215 Beltway" and "Cougar Ave and Wigwam Ave – Rosanna Street to Rainbow Blvd.". The improvements generally consist of hot mix asphaltic concrete pavement and/or rehabilitation of existing asphalt pavement, ADA upgrades, traffic signal modifications, upgrade lighting to LED, FAST ITS improvements, traffic control devices, pavement markings, median island installation/modifications, new storm drain and storm drain drop inlets, relocation of school flasher, vertical relocation of surface utilities, relocation of required utilities and other miscellaneous improvements along the proposed project limits.

ESTIMATED COST: \$9,644,114 - \$10,659,284.
