CCC 10.18.010 (g) A permit to keep an exotic or wild animal may be issued for the period prescribed by the animal control officer upon payment of a fee and a favorable inspection by an animal control officer of each location where the animal is to be kept. The permit authorizes the keeping of the individually permitted animal only in accordance with the conditions and restrictions imposed thereon, and does not authorize exhibition, unless expressly provided therein. A new application and a new fee is required in order to extend the time period or to change or remove any condition or restriction.

All permits are subject to a mandatory location inspection and applicable fees. Clark County Animal Protection Services reserves the right to revoke any permit should the permit holder be in violation of any provision within Title 10.18.040 of the Clark County Code.

\*\*\*Applications without supporting documents will not be approved. Permit applications must be dropped off in person at the Russell Campus Monday -Thursday 7:30 am - 5:00 pm.\*\*\*

Permits must be renewed each year. Non-compliance of CCC Title 10 may result in prosecution.

Owner/Custodian initial each item below confirming you understand the following requirements:

- A permit issued under the provisions of this chapter shall expire one (1) year from the date of issuance.
A permit holder shall allow inspections of the premises by the Animal Control Officer at any reasonable time.
Circumstances, if any, including exhibition, under which the animal will be removed from quarters, and methods of transportation.
The name, address, and phone number of applicant and any other person to be placed in charge of the animal including one 24-hour emergency contact phone number.
Animals will not be bred.
Direct contact between the public and the animals will not occur unless a detailed plan is approved by the Animal Control Officer.
A current color photograph of the animal.
A written program of veterinary care and a veterinarian's certificate, certifying that said animal is vaccinated in accordance with the law and possesses no health hazard to itself, other animals, or the general public.
A copy of accreditation documentation for animals that will be exhibited for public or private viewing.
Any other lawful conditions or restrictions appropriate for the control and protection of the animal, or protection of the public in relation thereto as set forth by the Animal Control Officer, which may include, but need not be limited to written contingency plans for dealing with escape; electronic microchip implantation; and liability insurance for person and property, which shall not be required to exceed two-hundred fifty thousand dollars (\$250,000).
In addition to any cage requirements set forth in the Exotic or Wild Animal permit and the prohibition against letting animals run at large, every person who is the owner or custodian of an exotic or wild animal, and keeps the same upon his premises under his control, shall keep the animal restrained at all times by fence, cage, coop, chain, leash or other adequate means so that said animal shall not leave or escape from the premises upon which it shall be kept.
In the event of an escape, the owner shall be liable for all costs related to its recovery or impoundment. Any impoundment thereunder may be performed as a securing or summary abatement in accordance with Chapter 11.08 in coordination with Animal Control.
Animal Control may revoke, suspend, or refuse to renew any exotic or wild animal permit upon good cause, including for failure to comply with any provision of this title provided that the violator shall be first notified of the specific violation, or violations and if the violation can be remedied, the violator shall have fourteen (14) days after receiving the notice of violation to correct the violation. The foregoing shall not be construed as to require a hearing before seizure of the animal, if reasonably necessary to protect health, safety, or welfare.
