Southern Nevada played host to “America’s Party” welcoming an estimated 400,000 locals and visitors to the Strip and Downtown. More than 80,000 fireworks were on display for all to enjoy.

Coordination between Metro, the resorts, and agencies such as the Clark County Fire Department, Clark County Public Works, the Nevada Department of Transportation (NDOT), and others begins a full year in advance. Our Public Works Department implemented up to 4,200 crowd-control metal barricades on the Strip and in the early morning hours of 2020 crews worked to collect more than 12 tons of trash.

In advance of the big night, Commissioner Naft thanked the thousands of law enforcement officers, first responders, and local, state, and federal employees who work hard throughout the year to ensure the safety for all who reside and visit southern Nevada. “Their tireless work must never go unrecognized,” said Naft.

In Searchlight, Commissioner Naft toured the Walking Box Ranch. Founded in 1931 by Rex Bell and Clara Bow as a working 400,000 acre ranch, it was listed on the National Register of Historic Places on January 30, 2009. He participated in many holiday events this December, including Hanukkah Menorah Lightings in Inspirada and at the T-Mobile Arena, The District at Green Valley, and the Clark County Government Center. Commissioner Naft met with many small business owners at ribbon cuttings and networking events, including the Berkshire Hathway Home Benefits group and Campbell Jones Cohen CPAs. THE JAYCEES SENIOR CITIZENS MOBILE HOME COMMUNITY IS A CLARK COUNTY GEM

The Las Vegas Jaycee's Senior Citizens Community is a gem in Clark County. The park, which first opened in 1993, is the result of a transfer of 80 acres of public land to the Housing Authority of Clark County in 1988. It was created explicitly for use as a low-income residential community for senior citizens. The community is incorporated as a non-profit for the advancement of low-income senior citizens and is managed by trustees which form the board of directors. The trustees are responsible for preparing the annual operating budget as well as other financial management activities related to the property.

In December, Commissioner Naft had the pleasure of touring the complex and visiting with a group of volunteers who were working to distribute holiday gifts to neighbors throughout the park. Also, in December, Commissioner Naft was pleased to recommend the appointment of State Senator Dallas Harris to the Board of Directors. Senator Harris was unanimously appointed by the Board of County Commissioners for the remainder of a four-year term ending June 30, 2023.
