Clark County Code Enforcement received 261 complaints of abandoned or unsecured properties in 2023 and so far this year there are over 130. When CCPRO received a complaint of a homeless encampment taking over an abandoned Pep Boys location, it was known that immediate action needed to take place. Even after the investigation began, over 25 additional complaints came in with additional concerns. LVMPD worked closely with Code Enforcement due to the rapidly growing number of squatters that were harboring within the dangerous building. There was criminal activity taking place everyday, such as drug abuse and the destruction of property. The large glass store front had been shattered, littering glass all over. Due to its conditions and the unsafe environment, the property was declared an imminent danger. With swift assistance from Code Officers, and LVMPD Southeast area command, the property was cleared of all trash, debris, glass and vagrants. Contractors installed boarding along the store front to prevent further break-ins or occupancy. A lien in the amount of \$4,550 was placed on the property.

A STICKY SITUATION

Glue traps work by trapping pests in one place and simply letting time do the rest. Some may say this is a grim way to go about pest control considering the possibility for other animals getting stuck in the traps.

Officer Wythe recently responded to a call for a baby snake caught in a glue trap and unable to free itself. Often, animals stuck in glue traps can cause substantial injury to themselves while struggling to break free, and thankfully the snake was still in good condition when Officer Wythe arrived.





After consulting with Senior Dispatcher Negri, Officer Wythe was able to gather the necessary supplies to help the snake. Cooking oils or baby oil can be used to deactivate the adhesive in glue traps, and in this case Officer Wythe used olive oil to free the snake.

Once the animal was free of the glue, Officer Wythe wiped the snake of any remaining oil, this helps to prevent the snake from smelling like oil and becoming more obvious to predators!

Officer Wythe set the snake free outside, far from public areas and the property owner was very happy.

RAPID ABATEMENT

Code Enforcement received a complaint of numerous tents occupied with vagrants and littered with large amounts of trash and debris. Upon inspection, and based on the officer's familiarity with the problem property, a Notice of Abatement was posted. The property owner contacted the officer explaining that he had been out of state and would be coming home soon, promising to have the property cleaned by the following weekend. Failing to keep his promise, the property was abated with removal of all trash, debris, tents and vagrants. The property was liened in the amount of \$1,998.00 and the surrounding neighbors were happy.

In Early August, Code Enforcement received a call from a concerned neighbor reporting a green pool next door. When the officer arrived he could not verify the complaint so he contacted the reporting neighbor, thankfully the neighbor allowed the officer to view the pool from a second story window. The officer was advised the home had been for sale and the officer was able to make contact with the realtor who stated the property was awaiting a short sale and they would remedy the violation immediately. Unfortunately, this did not happen and the officer took quick action to have the pool drained. A fee of \$350 was assessed to the property and the neighbors were happy that the mosquito haven was removed.





CLEARING THE CAMP

In an appreciated twist of cooperation and community spirit, this property owner has successfully cleared a vagrant camp from his property without incurring any fines or fees. 

materials and equipment to cover over the graffiti. Great work Graffiti Abatement Team!






SUCCESSFUL ABATEMENT

It is not unheard of for Clark County Code Enforcement to respond to the same property on multiple occasions. This is one of those occasions. CCPRO received a complaint of a squatter house. Upon receiving the complaint, the case was assigned and the Officer quickly responded. The initial inspection of the property did not show signs of people, but during the inspection it was found that the property had very large amounts of overgrown weeds in the yard as well as trash/debris in the form of plastic bags, branches and buckets. A Notice of Violation was sent to the property owner. While performing routine additional research, an email was sent to NV Energy and verified that there was no active service at the property. During the routine re-inspection of the property, the officer found that there was no change to the condition of the property which the officer deemed necessary to post and issue a Notice of Abatement. Due to no response or action from the property owner the abatement was scheduled and completed. After another successful cleanup, a lien was issued in the amount of \$1020.00.
