Todd Velelago of Velelago Petsch Architects, Inc. explained and provided pictures of the site plan and improvements for which St. John the Baptist Catholic Church is requesting.

BOARD OF COUNTY COMMISSIONERS STEVEN SISOLAK, CHAIR - CHRIS GIUNCHIGLIANI, Vice-Chair SUSAN BRAGER - LARRY BROWN – JAMES GIBSON - MARILYN KIRKPATRICK - LAWRENCE WEEKLY YOLANDA KING, County Manager Dave Bauermeister voiced his opposition to the expansion project due to his concern with the dust, hours of operation, and the noise since his property is adjacent to the church.

The hours of operation were read by Vice Chair Kathy Ochs and Mr. Velelago responded to the issue of the dust. He said a ¾ inch to one inch of crushed gravel will be applied to the parking lot with a coating on top. This will minimize any concern regarding dust abatement.

Vice Chair Ochs moved to approve item WS-18-0684 with staff recommendations. Chair Maniaci seconded the motion. Motion approved upon a voice vote, 4-0.
