Capt. Taggard said there has been an increase in structure fires this month which included apartment fires and motor home fires.

In June, the Fire Department, in conjunction with Metro and City of Bullhead City, will have multiple casualty shooter training.

The Laughlin Water Reclamation Facility (LWRF) had an average of 1.84 million gallons per day producing clean water returned to the Colorado River. Flow increased 80,000 gallons per day from this time last year.

Among the highlights:

➤ 4-H is going well with preparations being made to wrap up the after-school programming for the year. An end-of-the-year party is being planned for the kids.

The Searchlight kids are currently working on the Lego robotics kits and making good progress. Sixteen kids attended the last session. Planning is underway for a 4-H summer mini- camp that would also introduce the kids to desert gardening which has been a popular activity with the Laughlin kids.

➤On Saturday, March 30th, UNCE held a free Introduction to Desert Gardening Seminar at the Laughlin Library. Dr. Angela O'Callaghan, horticulture specialist from the Las Vegas office, provided the instruction. Thirty-five persons attended the seminar which generated quite a bit of positive feedback. Buddy Borden and Will are hoping that additional gardening seminars can be held in the near future.

➤GTI has confirmed that it will be putting in the new irrigation for the community garden with a starting date of April 9th. It is expected that the garden should be fully operational by Wednesday or Thursday of this week.

April 12th is the Spring Mixer to be held at the Laughlin Chamber from 5:00 to 7:00 p.m. This will include catered food and entertainment.

The Laughlin Tourism Commission (LTC) does not have an executive director at this time and the Chamber is providing administrative assistance until the position is filled. The LTC will not be doing any concerts and will only do the six events that are on the calendar now.

Chair Mackey requested future updates to include new members from Laughlin who have joined

the Chamber. Ms. Mazzeo said there was one new member recently but there have not been any new businesses or recent interest by existing businesses in Laughlin at this time.

A fundraiser was held March 24th for medical transportation. There was a good turn-out of 126 bowlers with over \$4,000 raised. The fundraiser included a silent auction, raffle prizes, and a 50/50 raffle.

During the Laughlin River Run to be held April $24^{th} - 28^{th}$, the big busses will deviate off of Casino Drive during the peak hours from 3:00 p.m. Friday and Saturday until 12:00 a.m. Busses will utilize Harrah's gas station at the south end of Casino Drive with passengers being transported to smaller busses that will run the remainder of Casino Drive.

The grant application for NDOT is in the process of being completed for grant cycle years 2019-2020. Currently, three new 40-foot busses and a 14-passenger paratransit bus will be delivered in the near future.
