## COVID-19 TESTING OPERATION OPENS AT UNLV THOMAS & MACK



The new community-based COVID-19 testing site inside the UNLV Thomas & Mack Center is now accepting appointments online through UMC's website at [www.umcsn.com](http://www.umcsn.com). The site is in the Thomas & Mack Center's Strip View Pavilion, located on the northwest side of the Thomas & Mack Center off Tropicana Avenue and University Drive.

The site is being operated by Clark County, UMC and the Nevada National Guard in partnership with UNLV and University Police Services.

"I'm grateful to the Nevada National Guard and UNLV for their collaboration in helping us make COVID-19 testing available to all interested members of our community", said Commissioner Michael Naft.

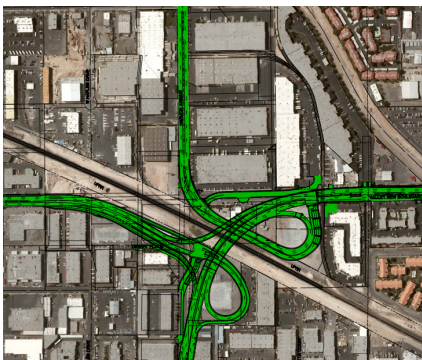


# HARMON-VALLEY VIEW OPEN FOR BUSINESS

Commissioner Michael Naft and local business owners opened the Harmon-Valley View project on August 19. The project connects and extends Harmon Avenue and Valley View Boulevard with several bridges and ramps over the railroad tracks. Prior to construction, the railroad tracks interrupted these streets where they intersect.

"This project improves access for businesses and residents navigating one of the busiest areas in Clark County," said Commissioner Michael Naft, whose Commission District A includes this area. "This project will help local businesses serve The Strip, while easing congestion on arterials frequented by locals."

This project provides the final link in the continuation of two important transportation corridors, Harmon Avenue and Valley View Boulevard. The first phase of the project was completed in 2004. The completion of this latest phase of the project is expected to alleviate congestion on Tropicana Avenue and Flamingo Road by providing another way to access the resort corridor. Harmon and Valley View are each expected to serve more than 40,000 vehicles per day by 2025. Construction on the Harmon-Valley View project began in January 2019.

“Our website is an important means of accessing County services and information,” said Commissioner Michael Naft, a vocal advocate for the update. “It should be easy for residents and visitors to transact business online and this new website is definitely a step in the right direction, providing efficiencies for our customers and for the County itself at a time when resources are limited.”
