5. Discuss and develop activities for a National Public Lands Day Event to be held at Pyramid Canyon Park in the Colorado River Heritage Greenway Park and Trails on September 28, 2024.

Discussion: Debroah opens up for comments on the activity schedule with the option of reviewing each item event by event or move to the last page recap. Deborah had thanked Victoria for being gracious and asked if she would like to take on more. Kelly was able to join the meeting so Deborah asked her to review the seed ball project type of plants that would be best for our Seed ball project. Kelly has taken the incitive to move forward with ordering seeds and work with Anna and Devin with UNR. They have worked with a lady from a county fair who has guided her with what would be best for a butterfly garden. Kelly passed around a flier with samples of plants that would work and the things she will need. The have hand wash stations and trays. She has moved forward do to needing to submit requisitions. Deborah questioned if it was there understanding people would take their seedballs with

them and spread them around or leave them. It was determined that both would be done. For storing them they could be kept up to a year and best kept in trays and dry. It was mentioned we could use aluminum trays to store the seed balls. Deborah is truly thankful for Kelly stepping up and moving forward. Deborah request that all Kellys info be sent to her electronically.

Kathleen let the committee know that Joyce with the VIP's are ready to go with the music and grab bags and volunteers. The kite flying are will need help – Deborah has asked Alyssa if they could help with this table but it will be busy so please keep that in mind. Mark inquired about the number of kites left over and if we needed more.

Deborah reviewed the other events and updates. Not sure Jessie will make it. She will reach out to Chris

Mark inquired about tables – Kathleen assured them we will have tables. The A Frames signs are in the park office. The elk signs will have all the pop ups. Tammy is working on the info boxes but the ones we have are old and we need new ones. Kathleen, suggest we have first aid supplies in the info boxes. We will need more buckets for the water to hold anchor the pop ups Kathleen will get them. Kathleen has the event banners for the booths with one to hang and one for the front of the tables. Mark is putting in a request for a bounce house and working on the press release. He is working on the flier and mailer. He has access to a print shop that could also do poster size. Mark mentioned if we have talked to Silver Rider for transportation to the park, maybe setup an area in town for pickup and drop off in town. In addition, we could have copies of and hand out the park brochures about the park and items you may need when walking the trails.
