V. Informational Items

- 1. Receive a report from Metro regarding activity and statistics during the past month and other area crime concerns (for discussion only). Metro Sergeant Jeff Dean reported only 3 standard calls with no issues this month in the Mountain Springs area.
- 2. Receive a report from Clark County Administrative Services regarding the status of the use Permit for live entertainment at the Mountain Springs Saloon, Lovell Canyon shooting restriction, and any other updates from Clark County (for discussion only)
 Meggan will update the board via email regarding the live entertainment at the saloon.
 Lovell Canyon prohibits shooting due to the ongoing clean up. The County is proposing further boundaries for unlawful firearms areas due to the expanded residential growth. See attached maps.
- 3. Receive a report from NDOT regarding the on-going SR160 road construction project (for discussion only). Brandon was present from NDOT. The animal tunnel should be completed by the new year. The community brought up the issue of the newly installed street lights. The street lights they have installed are not what the community agreed upon initially. They were supposed to be low impact, amber lights. Apparently the plans indicate Type A (16,500 +/- 5%) or Type B (13,000 +/- 5%) with LED style, solar backup which amber color is not an option. NDOT Assistant District Engineer Mario Gomez said they would conduct a lighting study by the end of the month and get back to us on their findings.

Mailboxes were supposed to be installed on both the north and the south side of SR160. However, they are currently installed only on the north side. This is another issue that was not as agreed upon initially. Meggan said she will meet up with Don and set up a meeting with USPS to discuss and hopefully rectify this issue.

7. Receive a report from Law Enforcement Officers regarding shooting regulations in the Mountain Springs area (for discussion only)
Stephanie Clark, BLM Chief Law Enforcement Ranger, was present to discuss safe guidelines and

allocated areas for target shooting in the BLM areas. Restrictions apply to developed recreation areas. Always follow these guidelines: Never shoot over or from a highway or road, always use a backdrop, never deface or destroy trees, plants, signs, etc., carry in/out all debris, shells, targets, casings, trash, etc., do not use plastic pellets, exploding targets. More information can be found at the BLM website. It is unlawful to shoot 1/2 mile of a highway or within 500 feet of a public or private road.
