1. Receive a report from Metro regarding activity and statistics during the past month and other area crime concerns (for discussion only).

Metro Sergeant Jeff Dean reported only 3 standard calls with no issues this month in the Mountain Springs area.

2. Receive a report from Clark County Administrative Services on any updates from Clark County (for discussion only).

Michael Shannon was standing in for Meggan this month and indicated no reports at this time.

3. Receive a report from NDOT regarding the on-going SR160 road construction project (for discussion only).

Don Christianson and Brandon Monette from NDOT made a brief presentation on the status of the SR 160 project indicating the divided highway westbound towards Pahrump is almost done. Substantial completion of the project is anticipated for August 2020 with seeding of landscape in October. Questions related to signage, deceleration lanes, throat width, drainage and barrier height BOARD OF COUNTY COMMISSIONERS

#### were answered.

Lightmeter data indicated a difference in light intensity at several locations resulting in a special order of fixtures with a more yellow hue. NDOT will leave the new lights up for a trial period to seek input from residents regarding their preference.

1. <u>AR-19-400153 (UC-18-0863)-ACVLB FAMILY TRUST-90 & BUSTOS, AUGUSTINE C. JR TRS:</u> USE PERMIT SECOND APPLICATION FOR REVIEW for live entertainment.

<u>WAIVERS OF DEVELOPMENT STANDARDS</u> for the following: 1) reduce the interior side setback for an accessory structure (stage); and 2) reduce the minimum separation from a residential use for live entertainment conducted outdoors.

<u>DESIGN REVIEW</u> for an outdoor stage in conjunction with an alcohol, on-premises consumption (tavern) establishment on 2.8 acres in an R-U (Rural Open Land) Zone in the Spring Mountain Overlay District.
