#### 1. Call to Order

#### 2. Public Comment

Ms. Burgos asked if there were any persons present in the audience wishing to be heard.

- Robert (Bob) Adams, a member of the public who spoke on behalf of the Motorcycle Racing Association of Nevada (MRAN), conveyed to the group that he is concerned that the ACEC expansion(s) will limit the amount of motorcycle race courses for interested parties. Mr. Adams is interested in permanent protection of race courses, similar to what California has enacted in some areas.

Ms. Burgos closed the public comment section.

#### 3. Approve Meeting Minutes from November 28, 2018 (For Possible Action)

The committee motioned for the meeting minutes from November 28, 2018 to be approved.

#### 4. Provide Update(s) on Issues on the Tracking List (For Possible Action)

- A. Discuss and make recommendations to the BCC to consider requesting federal legislation regarding Sandy Valley Goodsprings and Jean Lake Eldorado Valley OHV Recreation Areas (Tracking List Item #18, *Michael Frye*)

Mr. Frye provided the Committee with maps and legislative language supporting Sandy Valley Goodsprings (SVG) as an OHV Recreation Area. The County supports the idea of

SVG as an OHV Recreation Area and would like to move forward with the Committee in drafting and submitting a resolution to the BCC.

The County does not support Jean Lake Eldorado Valley as an OHV Recreation Area because of the numerous conflicts in the area such as ACEC's, disposal boundaries, the building of a future airport in the area, and possible conflict with Air Quality standards.

**B. Update the Committee on Logandale Trails OHV Recreation Area in Lands Bill (Tracking List Item #3, *Charles Law*)**

Ms. Henson and the Committee brought forward a report to the Clark County Board of County Commissioners (BCC) approving and adopting a resolution supporting the designation of a portion of Logandale Trails on BLM land as an OHV Recreation Area through federal legislation; this resolution was passed on Tuesday, December 18, 2019.

**C. Update the Committee on Race Track GPS routes (Tracking List Item #4, *Donald Jackson*)**

Mr. Jackson provided the Committee updates and a map of race track GPS routes from across the valley.

**5. Identify Emerging Issues to be Addressed at Future Meetings (For Possible Action)**

The Committee discussed possibly adding Nelson Hills as an OHV Recreation Area in the future. The County has agreed to take a closer look at the Nelson Hills area. The Committee will discuss making recommendations to the BCC to designate the Nelson Hills area as an OHV Recreation Area at the next OHV Advisory Committee meeting.
