- V. Informational Items
  1. Welcome new CAC member, Gary Laswell, and returning members.
  2. Receive a report from Las Vegas Valley Water District regarding the current well levels, status of the Blue Diamond Water System and other related concerns (for discussion only) – LVVWD Derek Jackson stated that the water system is stable. He reported one of his employees noticed a leak on Cerrito Way and had the leak repaired the next day. Natalia Londono will be on maternity leave and Jordan Bunker will be replacing her until she returns.
  3. Receive a report from Metro regarding activity and statistics during the past month and other area crime concerns (for discussion only) – Sergeant Jeff Dean shared they will be getting an OHV side by side to patrol the area and for special events. They were able to get the side by side thru grants and he will bring it to a future CAC meeting.
  4. Receive an update on the Red Rock Bike Trail from a representative of the Red Rock Trail Partnership (for discussion only) – Sheila stated they are still waiting on final approval, hopefully by next CAC meeting.
  5. Receive a report from Clark County Administrative Services regarding the status of recent Land Use Applications (UC-18-0913, VS-18-0897 & NZC-18-0858), status of the Gypsum Resources zoning applications (WC-18-400232, MPP-11-00469 & MPP-11-0468), and other updates from Clark County (for discussion only) (for discussion only) - Meggan shared the Calico Basin patent easement application was approved at Planning and the portion of the Right of Way was denied, which was the same as this board voted. The Boarding Stable was held and will be brought back

to this CAC next meeting as the applicant wanted to add riding stables. The Non - Conforming zone change for the RV Park was approved at Planning, but did not include any of the CAC recommended conditions. It goes before the BCC and Commissioner Jones will look at all input. Lastly, Gypsum Resources will be held until April 17, 2019.

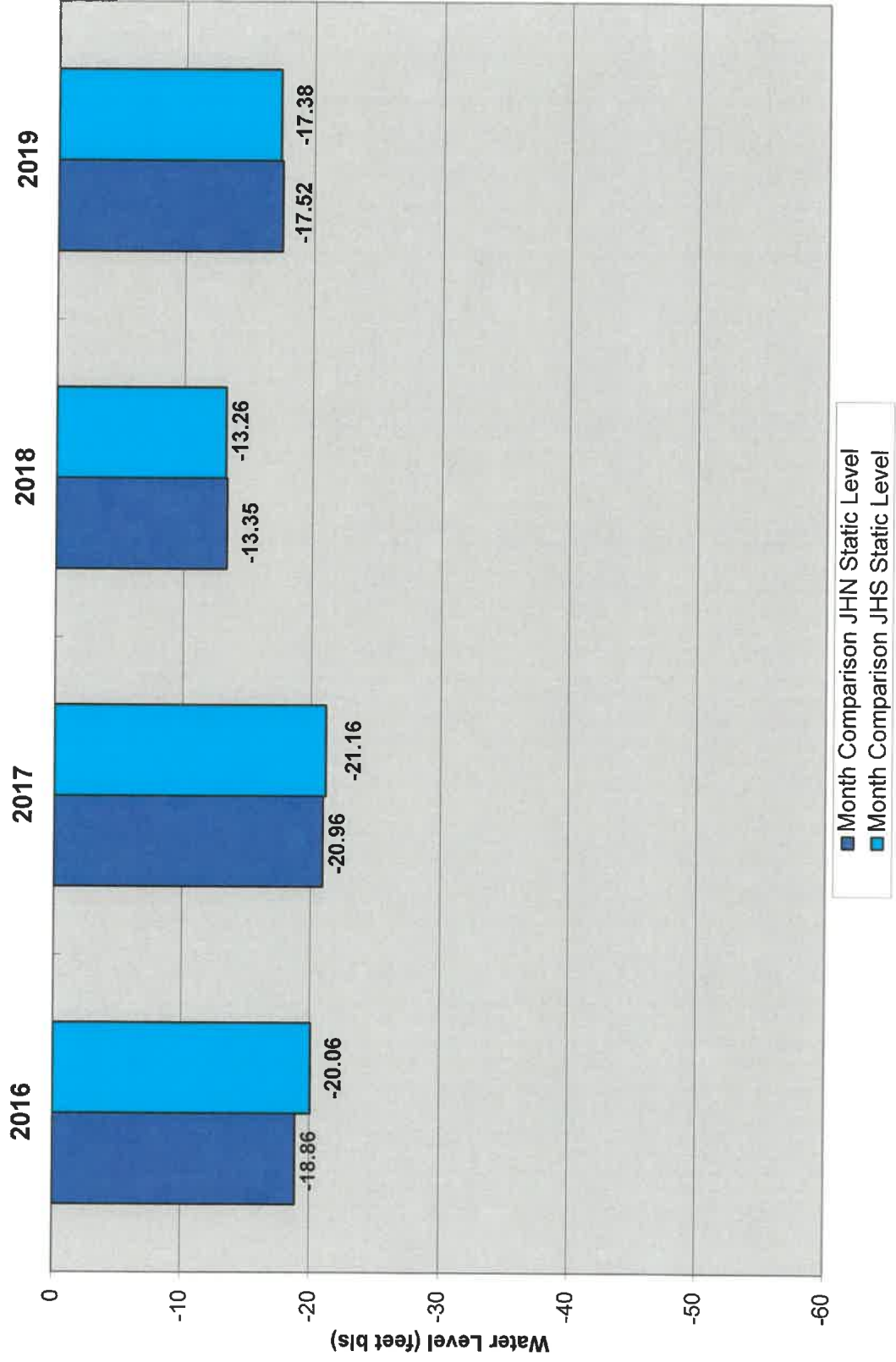
