### Significant Incidents:

- Ranger at Katherine's Landing was attacked and bitten by a dog off leash on a beach, sustaining minor injuries. Dog was impounded and owner was cited.
- Cottonwood rangers responded to PWC that caught fire and exploded near Katharine's landing. No injuries to occupants.
- Rangers conducted extensive planning and preparation for the arrival of hurricane Rosa. Initial forecast indicated out area getting a direct hit, but storm veered east and only minor showers occurred.
- Suspects in stabbing / attempted homicide on 9/7 at Stewarts Point in the north
  end of park have been arrested and are awaiting grand jury proceedings.
  Investigation indicated the three suspects attempted to kill a sleeping camper in
  order to steal his vehicle. The suspect was scared off when the victim's
  companion woke up and started yelling.
