Water usage was five million gallons for January 2019 which is an increase of 630,000 gallons from last year.

Beginning February 25th, the Water District will commence a 3-4 week project on a pipeline that runs from S-1 Well at the entrance of Searchlight to Nipton Road. An old pipeline is being excavated and being replaced with PVC which will be buried five feet to protect it from being washed out from the rain.

The work will only impact one service customer with public information staff working with that location. The costs of the improvements are covered by the Army Corp of Engineers.

Ellie Deever: As past chair of the Searchlight TAB, Ms. Deever has lived in Searchlight for 20 years. She has taught at various schools in California and Nevada. Ms. Deever is an artist and recently has started dance. She supports Searchlight and what's going on and invites everyone to get involved.

Janis Kostecky: Ms. Kostecky has lived in Searchlight since October 2014 and is the current president of the Senior Center. Beginning her first term as a TAB member, she is treasurer of the Museum Guild, Queen Mum of the local Red Hat Society, and mother to two children, one of whom resides in Henderson. In her spare time, she enjoys cross stitching.

Donna Moore: Ms. Moore moved to Searchlight part time in 2010 in preparation for retirement. Since 2015, she has become a permanent resident and is currently the property manager at Cree's Mobile Home Park. She has over 20 years' experience as an operational director at several large U.S. and international wireless telecommunication companies. Prior to her move to Searchlight, she was an operations manager for a large international chemical company. Ms. Moore is married and has a B.A. in Business Law and Business Administration/Operations.

Martin Batchelor: Mr. Batchelor has been a Searchlight resident with his wife Leesa for about 1.5 years. They moved here from Utah to work on Highway 95 south of Searchlight and liked the town and decided to stay. He applied for the town advisory board to be a positive and productive member of our community.

Mr. Batchelor has been in the transportation field for almost 32 years. During that time, he spent 20 years in the oil fields of Utah as a truck driver and five years as a safety representative before making the transition to traffic control dispatching. He also spent 10 years as a volunteer EMT and acquired an advanced certification with a specialty in pediatrics.

Kyle Myers: Mr. Myers has lived in Searchlight his entire life and has been employed by the local restaurant since 2010. His interest in politics was sparked in high school as he always wanted to be involved with his community. In 2016, he was elected to his first term on the town advisory board, serving as vice chairman. In 2018, he was re-elected to the board and is currently serving as chairman. He appreciates this opportunity from the community to serve on the board and is hopeful Searchlight can be a great place to live for the children and their children.

Jane Overy said she served on CDAC for 15 years and explained during that time, various capital improvements for Searchlight were completed, including two water tanks, a fire truck, an ambulance, a fire hydrant, and new wells outside of town. Ms. Overy said that these were just a few of the things they were able to bring to town. She suggested that the board needs to look around town to see what is needed.
