## 1. <u>UC-18-0764-NEVADA ENVIRONMENTAL RESPONSE TR & LE PETOMANE XXVII</u> <u>INC TRS:</u>

**<u>USE PERMIT</u>** to allow a proposed public utility structure (utility pole and transmission lines) outside of a designated aboveground transmission line corridor.

**DESIGN REVIEW** for a proposed public utility structure (utility pole and transmission lines) on a portion of 4.2 acres in an M-1 (Light Manufacturing) Zone and M-2 (Industrial) Zone.
