Notes & Highlights

- 1- Newly-activated Traffic Signals began to be reported in January 2020.
- 2- A small cell site license application is the initial application for a small cell site from a wireless licensee, or an application to modify an existing small cell site.
- 3 - FixIt Clark County allows residents to report quality-of-life issues and request services. It replaces the previous reporting mechanism known as ClarkConnect. The historical data available includes inquiries from ClarkConnect.
- 4 - Wire Theft Replacement Completed metrics (tracking unit is in feet/foot). Reporting for both Wire Theft Replacement Completed and Streetlight Poles Down began Calendar Year 2023.
- 5 - March 2024 - One Call "Tickets Received" decreased due to the hiring of a third-party line locating contractor (ELM Utility Services) to assist the County with the backlog of tickets in locating and marking Public Works' subsurface facilities.
