CLARK COUNTY SENIOR CENTERS REOPEN TO VACCINATED RESIDENTS



After more than a year of being closed, Clark County's senior centers open to the public on Tuesday, April 6. This includes the West Flamingo Senior Center on Flamingo Road at Jones Boulevard which will remain open Monday through Friday, 8 a.m. to 5 p.m.

With more than 3 out of 4 people who are at least 70 years old vaccinated across Clark County and 54 percent of those 60-69, the time is appropriate for our centers to reopen. Additionally, it is expected that our population will continue to get vaccinated in the weeks ahead.

We are not out of the woods yet, so everyone must continue to wear their mask and social distance, and we will limit capacity to 50 percent, per state mandates. Attendance is by registration only. To register, call (702) 455-7742 or walk in. Session 3 classes will be held April 12 through May 22.

GOVERNOR SIGNS EMERGENCY DIRECTIVE ALLOWING FULL AND CLOSE-CONTACT SPORTS TO RESUME



"I commend the Governor for working with medical experts to safely allow full and close-contact sports to resume in Clark County and throughout the State of Nevada," said Clark County Commissioner Michael Naft.

Clark County residents can return to neighborhood basketball courts this month. The state of Nevada approved full-contact sports to resume and County officials said work crews were expected to complete the reinstallation of rims at more than 100 outdoor parks by April 1.

Basketball falls under full-contact and close-contact sports as defined by Section 2 of Nevada Governor Directive 039 and has been deemed reasonable to resume for practice and competitions. Teams planning to play are required by Nevada Directive 034 to develop and implement a Preparedness and Safety Plan as outlined in Section 11 of the Directive. Teams also must implement plans for continuous COVID-19 testing. Through the state's Nevada Health Response website, a full Nevada Guide for Adult & Youth Sports packet effective March 30, 2021 is available to help teams navigate the process.

In addition to basketball, full-contact and close-contact sports and activities include football, flag football, softball, volleyball, baseball, soccer, lacrosse, ice hockey, group cheer, group dance, wrestling, rugby, boxing, martial arts, pair figure skating, field hockey, fencing, rowing, kickball and water polo.

The latest information for sports activities in Nevada is listed in Directive 042.

NAFT AND LVMPD TRAFFIC BUREAU TEAM UP TO HIGHLIGHT RECENT HIT AND RUN INCIDENTS

Commissioner Naft and the LVMPD Traffic Bureau held a press conference to discuss two unsolved hit-and-runs involving pedestrians. During the press conference, Lt. Greg Munson said there have been six fatal hit-and-run crashes so far this year. Last year, there were 10 total for the year. The first crash happened on Feb. 20. Police say 63-year-old Ronald Smith was struck while crossing Twain Avenue at Palos Verdes Street. The second crash happened on March 15 near East Lake Mead and North Lamb boulevards. FIRE DEPARTMENT WELCOMES NEW RECRUITS

The Clark County Fire Department hosted a ceremony at the Mandalay Bay Convention Center to celebrate the graduation of Fire Academy recruits who completed 18 weeks of training. The graduating class adopted the name “Pandemic’s Pride” in reference to the impact COVID-19 has had on them since the start of their training in October 2020. COVID-19 testing, social distancing and other disease mitigation procedures were in place throughout the training as well as the ceremony with family members and Fire Department staff. “Our fire academy training is rigorous under normal circumstances, but COVID-19 adds a whole new dimension in terms of the mitigation measures we put into place during classroom instruction and field training,” said Clark County Fire Chief John Steinbeck.
