BUSINESS LICENSE UPDATE FOR UBER AND LYFT DRIVERS

The Clark County Business License Department is publishing this notice to inform licensees holding a Driver DRI – Independent Contractor license (Uber, Lyft, etc.) of important updates regarding the 2022 license renewal period. Please see the **Clark County website** for current updates and to answer questions regarding opening or renewing a license. Due to lengthy wait times and limited lobby capacity, select license services will be available by appointment on a first serve basis. Please note that masks are required in the County offices for vaccinated and unvaccinated persons.

The \$25.00 annual license fee can be paid by credit or debit card (with a 2.65% processing fee) or ACH payment (no additional fee). For any payment method listed above, please retain your receipt of payment with you while your laminated card and license certificate are in transit.

Additional Information:

- **Lobby Services: Select license services are limited and by appointment on a first serve basis.** Appointments for application processing and requests for changes to licenses can be made at:

- **Change of Address:** If the location address has changed from the prior renewal period, a change of address form must be submitted with the \$25 change fee. If this is not submitted prior to your renewal, the laminated card and license certificate will be mailed to the former location address on file.
- **New Driver Card Format -** The newly formatted laminated card and license certificate will be mailed together and should arrive within 5- 7 business days. Any vehicle used for transportation in McCarran Airport must display the laminated card on the inside lower right of the vehicle windshield. The license certificate should also remain in the vehicle as proof of license ownership.
