Statement by the Director of Business License

All licenses, permits or findings of suitability are conditioned upon compliance with all provisions of Zoning, Building, Fire or other Codes, State Gaming Statutes and regulations as applicable, Health Department regulations and the payment of Business License fees and investigation fees, as required by Ordinance or Regulation, unless specifically waived in code.

Licenses approved by the Director may not be activated until a final inspection and sign-off are received from an Agent of the Department of Business License.

Any Liquor License not placed into operation within sixty (60) days of the Director approval is automatically revoked.





1. All renovations and rebranding must be completed prior to opening. This includes a site check and code conference by the Assigned Special Agent.
2. No Bottle Service allowed (this does not include bottles of wine or beer).
3. Must comply and cooperate with LVMPD, and all state and local agencies.
4. An owner or key employee must be on premises at all times the business is open.
5. All employees must have required cards in their possession at all times they are working.
6. Any violation of these conditions may result in automatic revocation of license.
