**TERMS AND CONDITIONS**

- 1. THE PERMIT SHALL BE SIGNED BY **PERMITTEE** ON PAGE 1 AND RETURNED TO THE DISTRICT OFFICE.
- 2. THIS TEMPORARY PERMIT EXPIRES UPON COMPLETION OF THE EVENT.
- 3. THE TEMPORARY RIGHT-OF-WAY OCCUPANCY PERMIT SHALL BE KEPT AT THE SITE OF THE EVENT AND MUST BE SHOWN TO ANY REPRESENTATIVE OF THE DEPARTMENT OF TRANSPORTATION OR ANY LAW ENFORCEMENT OFFICER ON DEMAND. **THE EVENT SHALL BE SUSPENDED IF THE PERMIT IS NOT AT THE SITE AS PROVIDED.**
- 4. THE **PERMITTEE**, IN ADDITION TO OBTAINING THE TEMPORARY RIGHT-OF-WAY OCCUPANCY PERMIT MUST ALSO OBTAIN ANY AND ALL OTHER PERMITS REQUIRED BY STATE LAW OR LOCAL ORDINANCES.
- 5. THE **PERMITTEE** AGREES TO INDEMNIFY AND SAVE HARMLESS THE STATE OF NEVADA AND ITS OFFICERS, AGENTS, AND EMPLOYEES AGAINST ANY AND ALL LIABILITY, LOSS, DAMAGE, COSTS, FEES AND EXPENSE WHICH IT OR THEY MAY INCUR, SUFFER, OR BE REQUIRED TO PAY BY REASON OF DEATH, DISEASE, OR BODILY INJURY TO ANY PERSON OR PERSONS, OR INJURY TO, DESTRUCTION OF, OR LOSS OF USE OF ANY PROPERTY, INCLUDING PROPERTY BELONGING TO THE STATE OF NEVADA, ARISING OUT OF OR INCIDENT TO ACTIVITIES CONTEMPLATED BY THIS PERMIT, AND PROXIMATELY CAUSED, IN WHOLE OR IN PART, BY ANY ACT OR OMISSION OF THE **PERMITTEE**, OR ITS CONTRACTORS, AGENTS, OR THE EMPLOYEES OF ANY ONE OR ALL OF THEM OR BY THE OFFICERS, AGENTS, OR EMPLOYEES OF THE STATE OF NEVADA, UNLESS IT IS ESTABLISHED BY THE **PERMITTEE** THAT THE PROXIMATE CAUSE WAS THE WILLFUL MISCONDUCT OR GROSS NEGLIGENCE OF THE OFFICERS, AGENTS, OR EMPLOYEES OF THE STATE OF NEVADA.
- 6. THE **PERMITTEE** SHALL PROVIDE A CERTIFICATION OF INSURANCE NAMING THE STATE OF NEVADA DEPARTMENT OF TRANSPORTATION AS ADDITIONAL INSURED (\$1,000,000 MINIMUM-GENERAL LIABILITY INSURANCE).
