NOTIFICATION OF PROPOSED AMENDMENT TO CLARK COUNTY CODE TITLE 12, CHAPTER 12.50 – SCRAP METAL PURCHASES (NEW) AND TITLE 6, CHAPTER 6.04, SECTION 6.04.140 – PENALTY FOR VIOLATION

Dear Licensee and Community Partners:

Pursuant to NRS 237.080, please be notified of proposed amendments to Clark County Code, Title 12, Chapter 12.50 – Scrap Metal Purchases (new) and Title 6, Chapter 6.04, Section 6.04.140 – Penalty for Violation. The amendments are available for your review online at www.clarkcountynv.gov/depts/businesslicense.

Specifically, the proposed amendments will revise sections of Title 12, Chapter 12.50 (new) and Title 6, Chapter 6.04, Section 6.04.140 regarding the purchase of scrap metal. The proposed amendments address the following key areas:

- **Section 12.50.010** makes it unlawful to purchase scrap metal, including scrap metal in the form of seven-strand copper wire that has been burned in whole or in part to remove insulation, in certain circumstances.
- **Section 12.50.020** exempts business-to-business transactions from the requirements of Section 12.50.010 when specific conditions are satisfied.
- **Section 12.50.030** provides for the enforcement of this Chapter by certain persons.
- **Section 12.50.040** establishes penalties for violations of this Chapter.
- **Section 6.04.140** adds Chapter 12.50 for penalties for violations.

In accordance with NRS 237.080, business owners and interested parties may submit data and arguments to the Clark County Board of Commissioners, in care of the Department of Business License as to whether the proposed amendment will:

1. Impose a direct and significant economic burden upon a business; or
2. Directly restrict the formation, operation or expansion of a business.
