Please complete the following requirements prior to submitting your application. Incomplete applications will be terminated or returned. Application should be submitted within 30 days of opening; all construction and tenant improvements must be complete.

DETERMINE JURISDICTION AND LAND USE:

□ NEVADA STATE BUSINESS LICENSE/ REGISTER WITH THE NEVADA SECRETARY OF STATE:

NRS 76 requires all businesses, corporations, and partnerships operating in the State of Nevada to have a State Business License. All corporations, limited liability companies, partnerships, etc. are required to register their entities. Please visit the <u>Nevada</u> <u>Secretary of State's</u> website for more information. REGISTER WITH THE NEVADA DEPARTMENT OF TAXATION:

You can now register online by visiting the <u>Nevada Department of Taxation</u> website or apply online at <u>nvsilverflume.gov</u>. Nevada Department of Taxation (1st Floor), located at 555 E. Washington Las Vegas, NV 89101. Telephone: (702) 486-2300

 REGISTER YOUR BUSINESS NAME (DBA): Businesses operating under a fictitious firm/doing business as (any name other than the business owner's legal name or the entity name registered with the Nevada Secretary of State) must file for a Fictitious Firm Name certificate with the <u>Clark County Clerk's</u> Office. Telephone: (702) 455-4431. Visit link for multiple locations http://www.clarkcountynv.gov/clerk/Services/Pages/FictitiousFirmNames.aspx. The filing must reflect the Entity Type listed with the Secretary of State.

Note: A Fictitious Firm Name (DBA) is the name your business will use when advertising, including on store front, signs, business cards, websites, etc. Advertising under more than one name, will require multiple business licenses.

- PHYSICAL LOCATION REQUIRED: Proof of rights to the business location, complete the Landlord/Lessor information on Clark County Application-Physical locations are required, mailboxes or P.O. Boxes are not accepted.
 - **PAY FEES:** Fees in the amount of **\$45.00 one-time non-refundable application fee along with the business license fee.** The business license fee is based upon services and activities provided. If providing more than one service, multiple licenses may be required.

- APPLY FOR A HEALTH PERMIT (if applicable): Proof that you have applied with the Southern Nevada Health District (SNHD). Telephone: (702) 759-1258 (food plan review) or (702) 759-0572 (aquatic health program). Health permits apply to food establishments and businesses operating public pools/spas.
- STATE BOARD APPROVAL (if applicable): Proof of your Nevada State License/Certificate from the following State Agencies: Contractors Board, Medical Board, Cosmetology, Nevada Barbers' Health and Sanitation Board, Nevada Transportation Authority, State Board of Pharmacy, Nevada State Bar, Private Investigator's Board, Nevada State Board of Accountancy, State of Nevada Real Estate Division or other regulatory agency. This additional requirement only applies to businesses that are governed by a regulatory board.

COMPLETE THE CLARK COUNTY BUSINESS LICENSE APPLICATION:

Online application portal <u>https://blepay.clarkcountynv.gov/NAICSDefault.aspx</u>. Online applications are exempt from additional documents; however we may request via e-mail for professional license or certifications.
