## Democratic Party

All of these contests will appear in the 2024 General Election. State Senate District 19 and State Assembly Districts 19, 22, and 23 had no Democratic Party candidates, so those contests will also have no Democratic Party candidates in the General Election. All the other contests had only one Democratic Party candidate and that candidate will appear in the General Election.

State Senate District 4, State Assembly Districts 7, 10, 14, and 28, and County Commission District B had no Republican Party candidates, so those contests will also have no Republican Party candidates in the General Election. All the other contests had only one Republican Party candidate and that candidate will appear in the General Election.

Offices with an asterisk (*) will not appear in the Primary or General Elections because, according to applicable laws: (a) The contest had no candidates and the office will be filled by appointment; and/or (b) The contest had less than twice the number of candidates to be elected, so the qualified candidate(s) that filed for the office will be declared elected. All other contests will appear in the General Election pursuant to applicable statutes, which vary by contest.
