

WHAT'S NEW IN NEVADA ELECTIONS

DEADLINE CHANGES, PER ASSEMBLY BILL 345 OF 2019

STANDARD CLOSE OF REGISTRATION DEADLINE: The current election's standard close of registration for mailing-in your voter registration application or for registering to vote in person, as well as for updating existing registration by mail or in person, has changed to the 4th Tuesday before Election Day. The requirement for extended office hours has been eliminated. The dates in 2020 will be:

- **May 12** for the Primary Election on June 9; and
- **October 6** for the General Election on November 3.

You may still register to vote or update your existing registration for the current election after the standard close of registration, either online, on the Nevada Secretary of State's website (www.registertovotenv.gov), or in person at any early voting site or election day vote center. See the following pages for details.

MAIL/ABSENT BALLOT REQUEST DEADLINE: The deadline to request a mail/absent ballot, IN WRITING, for the current election has changed to 5:00 p.m. on the 14th day before Election Day. Previously, the deadline was the 7th day before Election Day. If you registered online for the first time in Clark County, NV, after the standard close of registration (see above for dates), you may not vote by mail/absent ballot. The 2020 deadlines for submitting requests will be:

- **May 26** for the Primary Election on June 9; and
- **October 20** for the General Election on November 3.

DEADLINE FOR POSTMARKS AND RECEIVING VOTED MAIL/ABSENT BALLOTS: Voted mail/absent mail ballots must be postmarked on or before Election Day and received by the Election Department on or before the 7th day after Election Day. Previously, the Election Department had to receive voted mail/absent ballots by 7:00 p.m. on Election Day.

NEW PERMANENT MAIL/ABSENT BALLOTS, PER ASSEMBLY BILL 345 OF 2019

ANY VOTER FOR ANY REASON MAY NOW REQUEST A PERMANENT MAIL/ABSENT BALLOT: You may now make a one-time special request to receive a mail/absent ballot for all future elections. After submitting this request, you will no longer need to submit a mail/absent ballot request on an annual basis. The request will remain in effect as long as:

- You keep your address current with the Clark County Election Department; and
- Your voter registration is not canceled; and
- You do NOT vote in person instead of by mail during early voting or on election day.

If any of the above occur, you will need to re-apply for a permanent mail/absentee ballot if you want one again for all future elections.

**ALL PROVISIONAL BALLOTS WILL BE FULL BALLOTS,
PER ASSEMBLY BILL 345 OF 2019**

PROVISIONAL BALLOTS WILL HAVE ALL CONTESTS, CANDIDATES, AND QUESTIONS FOR THE VOTER'S PRECINCT: All provisional ballots will be full ballots, whether they are for the purposes of online or in-person same-day registration, online or in-person updates of existing registration, or the Federal Help America Vote Act (HAVA). This means they will contain all contests, candidates, and questions that are on a regular ballot for the voter's precinct. Provisional ballots will be counted only after verification of applicable voter information and that the voter did not cast multiple ballots in the same election. The Nevada Secretary of State and Clark County Election Department will have websites and toll-free phone numbers to inform voters of whether their provisional ballot was counted, and if it was not counted, why.

IMMEDIATE ONLINE OR IN-PERSON UPDATES OF EXISTING REGISTRATION AFTER THE STANDARD CLOSE OF REGISTRATION, PER ASSEMBLY BILL 345 OF 2019

HOW IT WORKS: You may immediately update online or in person at a voting site any of your existing voter registration data, including name, party, and address, after the standard close of in-person and mail-in registration. At any Clark County Early Voting Site or Election Day Vote Center, you may then vote a provisional ballot in the current election, with all contests, candidates, and questions that are on a regular ballot, including for your updated precinct and/or party, as applicable. Your provisional ballot will be counted only after verification of your registration data and that you did not cast multiple ballots in the same election. Note that if you only update your phone, e-mail, and/or mailing address that is separate from your residential address (if any), you will vote a regular ballot.

ONLINE UPDATES AFTER THE CLOSE OF STANDARD REGISTRATION: This is only available on the Nevada Secretary of State's website at www.registertovotenv.gov, starting the 4th Wednesday before Election Day and ending the last Thursday of early voting:

- **May 13-June 4** for early voting or election day voting in the Primary Election (*you will not receive a sample ballot with updated information for the current election if you make updates on or after May 20*); and
- **October 7-29** for early voting or election day voting in the General Election (*you will not receive a sample ballot with updated information for the current election if you make updates on or after October 14*).

IN-PERSON UPDATES AFTER THE CLOSE OF STANDARD REGISTRATION: This is available at any Clark County Early Voting Site or Election Day Vote Center of your choice during their hours of operation on the following dates:

- **May 23-June 5** (Early Voting) and **June 9** (Election Day) for the Primary Election; and
- **October 17-30** (Early Voting) and **Nov. 3** (Election Day) for the General Election.

ONLINE SAME-DAY VOTER REGISTRATION, AFTER THE STANDARD CLOSE OF VOTER REGISTRATION, PER ASSEMBLY BILL 345 OF 2019

HOW IT WORKS: After the standard close of in-person and mail-in voter registration, you may still register to vote online in the current election only on the Nevada (NV) Secretary of State's website at **www.registertovotenv.gov**. *This starts the 4th Wednesday before Election Day and ends the last Thursday of early voting.* You must have an unexpired, current NV Department of Motor Vehicles (DMV) Driver's License, NV State Identification Card, or temporary NV DMV "Interim Document" for online voter registration. Conditions and requirements apply:

- When you check-in at any Clark County Early Voting Site or Election Day Vote Center, you must show an unexpired NV DMV Driver's License, NV State Identification Card, or NV DMV temporary "interim Document" that has your current address where you actually live and which matches the address you entered for your online registration.
 - **IF** the address is not current (does not match your registration and/or is not where you actually live), you must also provide proof of your current residence, such as:
 - A military identification card; or
 - A utility bill (electric, gas, oil, water, sewer, septic, phone, cell phone, cable); or
 - A bank or credit union statement; or
 - A paycheck; or
 - An income tax return; or
 - A mortgage statement, or residential rental or lease agreement; or
 - A motor vehicle registration; or
 - A property tax statement; or
 - Any other document issued by a governmental agency.
- You must immediately vote at the site where your online voter registration is checked and confirmed, not at any other site.
- You will vote a provisional ballot with all contests, candidates, and questions that are on a regular ballot. Your provisional ballot will be counted only after verification that: (a) You were qualified to register to vote and cast a ballot in the current election; (b) You did not cast multiple ballots in the same election; and (c) **IF** applicable, confirmation you provided acceptable additional proof of residency.
- New Clark County registrants may not vote by mail/absent ballot, only in-person.
- You will not receive a sample ballot if you register to vote online 20 days or less before Election Day.

DATES: The specific 2020 dates for online same-day registration are:

- **May 13-June 4** for early voting or election day voting in the Primary Election (*no sample ballot for the current election on or after May 20*); and
- **October 7-29** for early voting or election day voting in the General Election (*no sample ballot for the current election on or after October 14*).

IN-PERSON SAME-DAY REGISTRATION AND VOTING AT ALL EARLY VOTING SITES AND ALL ELECTION DAY VOTE CENTERS, PER ASSEMBLY BILL 345 OF 2019

HOW IT WORKS: You may register in person and vote on the same day at any Clark County Early Voting Site or Election Day Vote Center of your choice. Conditions and requirements apply:

- You must show an unexpired Nevada (NV) Department of Motor Vehicles (DMV) Driver's License, NV State Identification Card, or NV DMV temporary "interim Document" that has your current address where you actually live and which matches the address for your voter registration.
 - **IF** the address is not current (does not match your registration and/or is not where you actually live), you must also provide proof of your current residence, such as:
 - A military identification card; or
 - A utility bill (electric, gas, oil, water, sewer, septic, phone, cell phone, cable); or
 - A bank or credit union statement; or
 - A paycheck; or
 - An income tax return; or
 - A mortgage statement, or residential rental or lease agreement; or
 - A motor vehicle registration; or
 - A property tax statement; or
 - Any other document issued by a governmental agency.
- You must immediately vote at the site where you register, not at any other site.
- You will vote a provisional ballot with all contests, candidates, and questions that are on a regular ballot. Your provisional ballot will be counted only after verification that: (a) You were qualified to register and cast a ballot in the current election; (b) You did not cast multiple ballots in the same election; and (c) **IF** applicable, confirmation you provided acceptable additional proof of residency.

DATES: The specific 2020 dates for in-person same-day registration and voting are:

- **May 23-June 5** (Early Voting) and **June 9** (Election Day) for the Primary Election; and
- **October 17-30** (Early Voting) and **Nov. 3** (Election Day) for the General Election.

PERSONS RELEASED FROM PRISON MAY IMMEDIATELY REGISTER TO VOTE, PER ASSEMBLY BILL 431 OF 2019

IF YOU ARE NOT CURRENTLY INCARCERATED, YOUR RIGHT TO REGISTER AND VOTE IS IMMEDIATELY RESTORED: Persons with felony convictions in Nevada or in any other state who are not in prison may immediately register to vote in Nevada. This also applies to persons whose voter registration had been previously canceled because of a felony conviction and to those who are currently on probation or parole. No special procedures or paperwork are required. Such persons need only satisfy the standard voter registration eligibility requirements and follow the standard procedures for registering to vote.
