Demolition Notification Form

Clark County Division of Air Quality

General Instructions: This form must be completed and submitted to the Department of Environment and Sustainability Division of Air Quality (DAQ) before a building or structure is demolished.

If the building or structure contains friable asbestos containing material, the NESHAP Notification of Asbestos Abatement Form (ASB_01) must be completed and submitted to DAQ. This form will not be accepted for reporting removal or encapsulation of friable asbestos containing materials from buildings or structures for demolition

This form must be received by DAQ no less than ten (10) working days before the demolition project is scheduled to start. Any notification that is incomplete or any notification indicating site activities to be in violation of applicable regulations will be considered an invalid notification. **Separate notifications** must be submitted for each building or other individual facility where demolition of said building or facility is to be demolished.

Under most circumstances, the removal of Category I non-friable asbestos containing materials will not be required prior to demolition, unless the building or structure is to be burned or the materials are in poor condition or will be handled in a manner that renders them friable. Category II non-friable asbestos containing materials must be removed prior to demolition of a building or structure, if the materials will be subject to crushing, crumbling or pulverizing during the process of demolition.
