- Contracted with the University of Nevada Las Vegas (UNLV) for soil and water analysis on the Clark County Muddy River Reserve (CCMRR), Project 561J.
- Contracted with the National Park Service (NPS) for botanical mapping and weed treatment on the CCMRR, Project 561N.
- Contracted with the Nevada Division of Forestry (NDF) for vegetation clearing and planting, site planting preparation, and minor repairs on the CCMRR, Project 561K.

Other Administrative Accomplishments

- Invoices processed = 53 invoices: 43 accepted (81%), 10 rejected (19%)
- Supplied documentation to independent auditor for FY11 Schedule of Expenditures of Financial Awards (SEFA) audit.
- Initiated inventory tracking log to track division assets. A database will be developed in the future.
- Coordinated with Clark County Finance office and Comptroller on transition to the Department of Comprehensive Planning.
- Working with financial advisor on maximizing return on fund balance.
- Continued process development for centralized fee collection of tortoise fees. Met with County project manager for a request for proposal (RFP) regarding electronic payment processing which will allow credit cards and other electronic payments.
- Awaiting direction from Department of Motor Vehicles (DMV) on next step for desert tortoise specialty license plate (currently 8th on DMV waiting list).
- Participated in four conference call meetings as a member of the Southern Nevada Public Land Management Act (SNPLMA) Streamlining Committee. The committee completed and issued a processes flowchart and a SNPLMA contacts list. Status on work in process will be posted on SNPLMA's website on a Process Log that will be updated monthly.
- Submitted necessary documentation for nomination of three SNPLMA R13 projects totaling \$3,195,604.
- Submitted necessary documentation for initiating two SNPLMA R12 projects totaling \$92,000.
- Prepared drawdown for FY09 (\$322,492) indirect cost reimbursement based on approved model. Working on calculation for FY11.

Wild Desert Tortoise Assistance Line

- The line logged 4 calls.
- Two wild tortoises were collected and transferred to the Desert Tortoise Conservation Center (DTCC).
- No non-desert tortoise were picked up and taken to the DTCC.

Public Information and Education (PIE)

- Outreach Products Developed products to provide information to the public regarding wild and pet desert tortoises. Outreach products include the following:

- Outreach Events Provided Mojave Max mascot appearances at five community events including Henderson Trails Day, two Halloween events and one appearance at the Red Rock Canyon Visitor's Center. Additionally, the following outreach efforts were completed:
 - Mailed poster and cover letter highlighting tortoise backyard breeding issues to all veterinarian offices and pet stores in Clark County
 - Mailed magnets on proper tortoise nutrition and cover letter highlighting tortoise backyard breeding and nutritional issues to over 370 tortoise owners
 - Distributed poster, cover letter, mouse-pads and decals to Henderson Animal Shelter and The Animal Foundation dba LIED Animal Shelter
- Mojave Max Education Program Continued planning and preparations for the 2012 Mojave Max Emergence Contest. Scheduled school assemblies, revised teacher training materials and Mojave Max assembly presentation materials.
- Public Information Videos Completed two additional public information and education videos
 promoting the messages of the Desert Conservation Program. "Desert Tortoise Troubles" uses local
 agency representatives to present Southern Nevada desert tortoise issues. Representatives from the
 USFWS and the BLM discuss the listing of the desert tortoise, the biology of the desert, and current
 desert tortoise research efforts and challenges. "Desert Dude or Dufus" uses animation to present
 desert "do's and don'ts" for an 8-12 year old audience.
