Other Administrative Accomplishments

- Began FY12 budget administration.
- Processed 54 invoices: 48 were accepted (89%), 6 were rejected (11%)
- Continued preparation of FY11 Schedule of Expenditures of Financial Awards (SEFA) documentation for County Comptroller.
- Worked with financial advisor on maximizing return on Desert Conservation Program (DCP) fund balance.
- Completed master projects list from 1999-2011.
- Completed design process for desert tortoise specialty license plate (moved up to 8th on Department of Motor Vehicles waiting list).

- Attended June Southern Nevada Public Land Management Act (SNPLMA) Executive Committee meeting and gave a presentation on SNPLMA accomplishments and status.
- DCP was added by SNPLMA as another rotating local government representative for the Partners Working Group.
- Received notification that because of our request for reconsideration and subsequent presentation, SNPLMA will fund both R12 project submittals.
- Prepared drawdown for FY10 indirect cost reimbursement based on approved model.
- Received reimbursement for 21 SNPLMA R6 projects for a total of \$1,900,409 and 14 R8 projects for a total of \$326,641.
- Status of SNPLMA change requests:
 - GBBO 581 Developing Habitat Models and Monitoring: time extension we have received the cooperative agreement and we are waiting for fully-executed document.
 - CC 1012 Desert Tortoise Monitoring: we have submitted a change in the scope of work and a reduction in the dollar amount. Further information will be submitted regarding the technical review by the United States Fish and Wildlife Service (USFWS).
- Completed and de-obligated the following SNPLMA R6 projects:
 - NPS 526 Monitoring of Illegal Ground Disturbance
 - NPS 529 Monitoring Road Conditions and Signs
 - NPS 535 Inventory, Research and Monitoring for Covered Plant Species

- Reassigned information technology (IT) support services from Department of Air Quality and Environmental Management IT to Central IT for cost savings purposes. Currently working with Central IT to develop a Service Level Agreement for support needs.
- Completed a design revision to the Milestone Review Workflow in Case 360, the DCP's contract and project tracking system.

- Participated in Clark County's process to update the South County Land Use Plan.
- Participated in TransWest Express Transmission Project Cooperating Agency bi-weekly conference calls.
- Provided comment letter to USFWS on Clark County Southwestern Willow Flycatcher Critical Habitat Exclusion areas.
- Provided comment letter to USFWS on status of Las Vegas Buckwheat.
- Provided comment letter to USFWS on status of two springsnails, *Pyrgulopsis deaconi* and *P. turbatrix*.
- Provided comments to Clark County on Gypsum Resources' Gypsum Reclamation Concept Plan.
- Provided comments to Department of Air Quality and Environmental Management on the Southern Nevada Water Authority Groundwater Resources Plan and Environmental Impact Statement (EIS).
- Performed a migratory bird impact site inspection for the Clark County Communication Tower which serves Laughlin.

Acquisition & Management of Acquired Easements, Property, Grazing Rights & Water Rights

- Maintained and managed the Clark County Muddy River Reserve (CCMRR) properties with regular weekly tasks.
- Prepared a restoration plan and submitted a grant proposal to the Walton Family Foundation.
- Completed the Perkins Pond Implementation Plan through management of the NPS 810A contract.

Boulder City Conservation Easement (BCCE)

- Completed 95% of the signage inventory.
- Began work on a database for all signage.
- Began creation of a GIS layer that includes finalized roads and signage.
- Began signage removal on all closed roads.

- Gave presentation on proposed finalize roads to Nevada Department of Wildlife, Bureau of Land Management and USFWS.
- Finalized roads and prepared documentation and maps.

- A new County OpenDoor Application was developed to help the DCP with management of the Boulder City Conservation Easement.

Wild Desert Tortoise Assistance Line

- The line logged 24 calls.
- Eleven wild tortoises were collected and transferred to the Desert Tortoise Conservation Center (DTCC).
- There were no non-desert tortoises picked up and taken to the DTCC.

Public Information and Education (PIE)

- Mojave Max Education Program Planning for the 2012 Mojave Max Emergence Contest. Scheduled school assembly dates and updated the student contest entry database. Created mojavemaxtv on YouTube and uploaded all videos to the site. Currently update the www.mojavemax.com website.
- Outreach Events Provided Mojave Max mascot appearances at 13 community events including National Night Out, Summerlin Art Festival and appearances at the Red Rock Canyon Visitor's Center.
- Public Information Videos Continued work on two additional public information and education videos promoting the messages of the Desert Conservation Program. The video "Desert Tortoise Troubles" uses local agency representatives to present Southern Nevada desert tortoise issues.
 Representatives will discuss the listing of the desert tortoise, the biology of the desert, and current

desert tortoise research. The video "Desert Dude or Dufus" uses animation to present desert "do's and don'ts" for 8-12 year old audiences.

- Contractors/Developers Outreach Effort Continued working with Joshua Tree Productions, Inc. to acquire Mojave Desert videos and photos for use in future training courses.
- PIE SNPLMA R6 Funds Continued to administer and close-out all R6 public information and education projects for project number CC 553. Projects must be completed and closed by December 31, 2011 in order for close out with the SNPLMA office to occur by February, 2012.

Desert Tortoise Fencing

• New contract with Nevada Division of Forestry (NDF) for fencing installation and maintenance (Project 804A) was awarded; NDF will provide fence installation, maintenance and data collection of fencing on public and private lands within Clark County for future DCP projects.

• Continued to prepare draft Amended MSHCP; preparing drafts of Chapter 6, Plan Implementation; Chapter 7, Implementation Costs and Funding Sources.



- Continued meetings with local development companies and other related stakeholders to discuss grading schedules and how desert tortoise clearances could be incorporated into that process with minimal disturbance. Received comments on Chapter 4 (Conservation Strategy) of the MSHCP from the USFWS; consultant delivered chapters 5-7 of the EIS.
- Continued to coordinate permit amendment progress with Permittees on a monthly basis.
- Continued meetings with BLM and USFWS to discuss permit amendment and related issues, including a proposed Reserve System; developed draft Cooperative Management Agreement for management of the proposed Reserve System and provided to BLM and USFWS for comment.
- Completed economic analysis of proposed conservation strategy.
