#### QUESTION 1: What did you accomplish during this reporting period? How did these accomplishments help you reach the goal of your project? If relevant, what indicators or benchmarks were used to determine your progress?

During the reporting period, our main project activity was entering and quality checking the 2024 field data from the spring 2024 field data collection season. Data entry also included reconciling unknown plants and assigning them species IDs where possible.

These accomplishments have us on track for meeting the benchmark of creating a full plant community database (as well as the substrate and site descriptions) to meet the upcoming D13 2024 Annual Data deliverable due December 31, 2024. We plan on continuing working on database preparation in the upcoming quarter to meet D13.

Additionally, on August 19, 2024, we met M08 (2024 Annual Project Review Presentation) by presenting the project at the annual DCP symposium.

# QUESTION 2: What, if any, problems were encountered? Briefly describe those problems and the manner in which they were dealt.

We did not encounter any unexpected problems. The main challenge we encountered, which was expected, was handling unknown plant species in the field and then tracking them through the field database preparation process to identify the unknowns where possible. In many cases, it was possible to identify unknowns at certain sites (or early in the field season) by then observing the plants later in the growing season as they matured to facilitate identification. A major part of the data entry process this quarter was reconciling the unknowns and identifying them as

possible. Plants not able to be identified reliably, by simply lacking required plant parts to do so, will be recorded to the finest taxonomic level possible (e.g., genus level).
