To provide restoration services to linear disturbances on the Boulder City Conservation Easement (BCCE), as the desert habitat on the easement has been damaged by Off Highway Vehicle (OHV) traffic. Site restoration is planned for ten project locations on the BCCE in the Piute-Eldorado Valley.

# The major accomplishment or findings of this project include:

Ten sites were restored to the extent that they were hidden from view and therefore did not invite new incursions. This helps to prevent further destruction and loss of native habitat and the loss of endangered desert plants and animals.
