The purpose of the above referenced project was:

The purpose of this project is to continue building a record of federally listed bird species and non-listed bird species currently present on the riparian reserve units and the Boulder City Conservation Easement by obtaining up to five additional years of survery data.

The major accomplishment or findings of this project include:

This project successfully built upon DCP's baseline dataset of avian species presence and distribution within the County's Riparian Reserve Unit and BCCE. All surveys were completed as scheduled, and this project resulted in the confirmation of breeding yellow-billed cuckoo at one of the riparian properties in Bunkerville. This was the first confirmed record of cuckoos nesting in Nevada since 2001 and only the third known breeding location in Nevada.
