The purpose of the above referenced project was:

The purpose of this project was to establish a baseline record of bird species currently present on the Boulder City Conservation Easement. These records can be used to detect changes in species presence and distribution over time and to inform future management actions at the BCCE.

The major accomplishment or findings of this project include:

Three rounds of avian point-count surveys were completed in the spring and summer of 2018 at 40 locations throughout the BCCE. A total of 23 avian species were recorded through this project, including two MSHCP evaluation species: loggerhead shrike (*Lanius ludovicianus*) and LeConte's thrasher (*Toxostoma lecontei*).
