**The purpose of the above referenced project was:**

The purpose of this project is to close off abandoned mine lands hazards in the Gold Butte National Monument and additional areas while maintaining habitat accessibility and functionality for wildlife including bats and desert tortoise.

**The major accomplishment or findings of this project include:**

Through this Interlocal Agreement with Nevada Division of Minerals, 18 wildlife compatible closures were installed at abandoned mine lands (AML) hazards in the Gold Butte National Monument, two at Valley of Fire State Park, and six at the Historic Goodsprings Mining District. All 26 of these closures meet the goal of this project to close off AML hazards, eliminating them as a danger to humans while maintaining habitat accessibility and functionality for native wildlife.
