The work for the above referenced project has been completed. Please see the attached for all project related information.

The purpose of the above referenced project was:

To determine the current status of peregrine falcons in Clark County through continued monitoring of historic sites, and discovery of new territories as aided by the development of a predictive habitat suitability model and map. Known peregrine territories will be surveyed for occupancy, nest success and productivity.

The major accomplishment or findings of this project include:

- Known breeding territories increased from seven in 2009 to 16 by the end of data collection in 2010. In 2010, 11 territories were occupied, and nine of those had a known outcome. Breeding success was 100% and productivity was 2.11 young/successful territories.
- There were one hundred forty-three (143) call broadcast surveys conducted and resulted in the discovery of at least 3 new breeding territories and 3 single peregrine detections. Several known and new territories outside of Clark County were also monitored in order to better develop and inform the draft habitat suitability model.
