The work for the above referenced project has been completed. Please see the attached for all project related information.

The purpose of the above referenced project was:

The purpose of this project is to reduce the extent of backyard breeding of desert tortoises within Clark County by providing sterilization training for veterinarians which will enable them to perform public clinics to help sterilize pet tortoises.

The major accomplishment or findings of this project include:

- Sterilizations were conducted on 54 (25 females, 29 males) pet desert tortoises
- Fifty-eight tortoises received micro-chips and were registered with tortoise group
- 26 veterinarians, veterinarian technicians, and veterinarian residents were trained in sterilization techniques
- Complications arose due to follicle size in females leading to a change in protocol where all females will receive an ultrasound before surgery to determine if they are a viable candidate in order to limit the stress to the animal
