### The purpose of the above referenced project was:

The purpose of this project was to restore habitat and improve approximately three miles of Mount Charleston's South Loop Trail system in response to damage caused by the 2013 Carpenter 1 Fire.

## The major accomplishment or findings of this project include:

A four-person crew cleared 72 logs from the South Loop Trail corridor, 45 drainage features were installed, 11 were maintained, and all tread surfaces and backslopes were reconstructed according to US Forest Service standards. The trail is now open for public use.
