RE: Submittal of Clark County's Revision to the Nevada State Implementation Plan for the 2015 Ozone NAAQS: Nonattainment Major NSR Requirements: Las Vegas Valley Nonattainment Area

Dear Ms. Adams:

On behalf of Governor Sisolak, as his appointed designee, this letter informs you of our transmittal submitted electronically to USEPA's State Planning Electronic Collaboration System (SPeCS) of revisions to the Clark County Department of Environment and Sustainability (DES) portion of the Nevada applicable state implementation plan (SIP). The revisions regard Clark County's nonattainment designation of the Las Vegas Valley (Hydrographic Area [HA] 212). The Nevada Division of Environmental Protection (NDEP) requests approval of the revisions into the Nevada applicable SIP.

This SIP revision certifies that Clark County's existing federally-approved Nonattainment New Source Review (NNSR) program is at least as stringent as the requirements of 40 CFR Part 51.165 or the 2015 ozone National Ambient Air Quality Standards (NAAQS), as amended by the final implementation rule. Upon review of the current SIP approved nonattainment major NNSR program, DES finds and certifies that no changes are necessary to comply with the 2015 ozone NAAQS NNSR requirements for the HA 212 nonattainment area. The submittal demonstrates that existing Air Quality Regulations (AQRs) satisfy the minimum requirements, with a table listing the 40 CFR Part 51.165 requirements necessary for DES to implement its NNSR program and the corresponding AQR provisions that satisfy these requirements.
