These Notices shall satisfy two separate but related procedural requirements for activities to be undertaken by Clark County.

### **REQUEST FOR RELEASE OF FUNDS**

On or about **Monday, May 12, 2025**, Clark County as the Consortium lead will submit requests to the U.S Department of Housing and Urban Development, Region 9 (HUD) and the Nevada Housing Division (NHD) for the release of HOME Investment Partnership (HOME) funds under Title II of the Cranston-Gonzalez National Affordable Housing Act of 1990, 24 CFR Part 92, as amended, to undertake a project known as Pecos Apartments, for the purpose of constructing two four-story buildings with 105 affordable apartment units within 157,593 square feet of building space. The new units would be made available to low- and very low-income families, and include amenities such as a playground, a pool, an outdoor amenity area, shaded parking spots, a walking trail, and several Americans with Disability Act-compliant parking spots. The site is 4.23 acres of vacant land at 6555 North Pecos Road, North Las Vegas, Nevada 89086, Clark County Assessor's Parcel Number 124-24-801-006.

## ENVIRONMENTAL CERTIFICATION

Clark County certifies to HUD that Karen Michelin in her capacity as Manager of Clark County Community Housing Office and Certifying Officer, Clark County, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows Clark County to use Program funds.

## OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of funds and of Clark County's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the County; (b) the County has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR, Part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in writing in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the U.S Department of Housing and Urban Development, HUD San Francisco Regional Office, One Sansome Street, Suite 1200, San Francisco, CA 94104. Objections on the use of CPD HOME funds may also be emailed to [rrofsfro@hud.gov](mailto:rrofsfro@hud.gov) and to the Nevada Housing Division via mail to Southern Nevada Housing Division Office, 3300 West Sahara Avenue, Suite 300, Las Vegas, Nevada 89102. Objections on the use of State HOME funds only, may also be emailed to [NHDgrants@housing.nv.gov](mailto:NHDgrants@housing.nv.gov). Potential objectors should contact the San Francisco Regional Office to verify the actual last day of the objection period.
