WHO CAN FOSTER

Supportive caregivers are willing to work alongside biological families and Department of Family Services to reunify children with their families.

- Ages 21+
- Renters | Homeowners
- Working | Stay-at-Home | Retired
- Single | Married | Divorced | LGBTQ

TYPES OF CARE

There are several types of foster care that may be suitable for your situation.

- Respite Care: short term support for licensed caregivers
- Standard Licensed Foster Caregiver
- iCare: short-term, on-call emergency care to avoid placement in a congregate setting
- Advanced Foster Care (AFC) for children with a higher level of need. Caregivers receive additional training and support.
- Relative or Fictive Kin: caring for children who are relatives, family friends, or are familiar adults to children in care

STEPS TO FOSTER

On average, it takes approximately 3 months to become licensed. However, you can speed up the process by taking expedited training or prepping for the home safety inspection.

- The first step to becoming a foster parent is to register for and attend an information session. Our team will share details about fostering children, teens, and siblings, and you will have the opportunity to ask questions.
- When you decide that fostering is the right thing to do, get your fingerprints and background check done. You can even get your fingerprints done at your information session.
- Turn in your application and documentation.
- Participate in foster parent training. Families complete 27 hours of coursework and classes include trauma informed care, CPR, and car seat training.
- Prepare your home and pass your home safety visits with help from your licensing worker. During this part of the process, our team will ensure you are ready to become a foster parent.
- Complete licensing process and welcome children, teens, and siblings into your family!

DOCUMENTS

Documentation includes but is not limited to:

- Application
- Fingerprinting / Background Check
- Marriage Certificate (if applicable)
- Nevada Driver's License
- Car Insurance
- Social Security Card or TIN
- Proof of Financial Stability
- Negative TB Test Results
- Children's Immunization Records
- Proof of Residency- Lease, Mortgage
- Renter's or Home Owner's Insurance

HOME SAFETY

Homes must meet the Nevada Revised Statutes 424 (NRS) and Nevada Administrative Code 424 (NAC) regarding Foster Homes. Refer to these codes for a full explanation.

Home safety examples include but are not limited to:

- Designated bedroom for foster child(ren)
- Working fire extinguishers (2-A 10BC)
- Working telephone or cell phone
- Medications stored in locked place
- Firearms/weapons stored in locked safe away from ammunition that must also be locked up
- Reliable and safe transportation
