Notes & Highlights

1 - Response time measures from call pick-up to first arriving unit on scene to all emergency incidents. CCFD response time goal is 7 minutes to 90% of the incidents.

2 - Private ambulances response zones include: Zones 1 & 2 (AMR), Zones 5 & 6 (MedicWest), and Zones 7 & 8 (Community). Zone 8 response area was established on 2/1/2022.

3 - Permits issued include construction, annual, renewal and temporary permits.
