I. Call to Order

Chairman Billy Samuels, LEPC Chairman, alright good morning everyone, I call this meeting to order, this is March 15, 2022, LEPC. It is 10:00. Go to Agenda Item #II. Andria will you do the roll call please and sign me present.

II. Roll Call

Andria Webster: Yes Chief, I have the LEPC Chairman Billy Samuels present, LEPC Vice-Chair Rachel Skidmore. Before I proceed, if I miss anyone on the call or for some reason there is a lag, go ahead and just email me or you can drop a note in the drop box that you were here present on the meeting and I will make sure I will write it down. Called roll and noted that a quorum was present.

Andria Webster: Alright Chief and with that we have made quorum.

Chief: Copy that (9:59). Please make sure you do have Art Perillo from Las Vegas Fire & Rescue. Chief Travis Anderson from North Town is on; Sean Simoneau from Henderson is on and there was one other that I thought needed to be marked, so make sure you get those right there.

Andria Webster: Thank you.

Chief: Thank you. Alright, we close out Agenda Item #II and go to Agenda Item #III

III. Public Comments

This is for discussion only. No action may be taken upon a matter raised under this item of the Agenda until the matter itself has been specifically included on the Agenda as an item upon which action may be taken. Public comments may be limited to 2 minutes per person at the discretion of the Chair. Persons may not allocate unused time to other speakers.

Comments will not be restricted based on viewpoint. Do I have anybody for public comment? So every now and then you guys all know we will have public comments ending this meeting and go on to say if you think something comes up during that time period, you will have the opportunity to discuss it then. Close out Item #III and go to Item #IV.

IV. Comments from the Chair: (Discussion Only)

This is going to be comments from the Chair. But one of the things I would like to discuss is we're going to start a working group. We do have the hazard mitigation plan that needs to be kind of addressed; it's an all hazard obviously and then this group is pretty much all hazard, with LEPC. This working group is going to be formatted and Co-Chaired with Misty Richardson and Jeremy Hynds from the City of Henderson. So this is (11:34) about this, but is a comment. Does anybody have any ideas, comments, on why we're going there; and Misty would you like to chime in on that?

Misty: Thanks Chief. One of the things that we have learned in past iterations of this plan and the updates is we really want to make sure that whole community involvement is there and so very early on in this process, I started looking at ways that we could change what we've done in the past to improve upon that and one of those things is keeping eyes on this in the community and (12:08) with the LEPC so that we can have some accountability for our state holders and a schedule so that we can update you on a regular basis and then get your (12:18) and also have a venue for our public meetings so that we can discuss the plan as required. So that's really the attention behind it; and if there are any questions, I am happy to entertain those off-line after the meeting if somebody would like to get in touch with me. Otherwise that's the direction and why we're doing what we're doing.

Male Voice: (12:43) I was wondering why, Misty, if Jeremy got picked because (12:47) their opinions and (12:49) what happens when you say something, do you usually get picked? So I appreciate (21:54) brings it up to me. It'll be good, I think they do need to do that, so I do appreciate both of them stepping up and doing that for us.

Chairman Billy Samuels: Alright, closing out Agenda Item #IV and going on to #V.

V. Review and Approve the Submittal of the 2022 HMEP Mid-Cycle Grant Application in the amount of \$20,608.00 for LEPC to send 7 individuals to Chemtrek International Hazmat Summit in New Orleans on September 12th to the 14th 2022. This is for possible action and Karen Taylor is going to express the details of it, please.

Karen Taylor: Jason Moyer from Las Vegas PD, are you still on? Okay, would you like to physically hear project, do you want to explain Chemtrek Conference to everybody?

Jason Moyer: Yeah, so the Chemtrek Conference, as everybody in the hazmat world knows, Chemtrek is the place we call for chemical information. We have hazmat incidents dealing with transportation, rail, etc. In September they are holding the International Hazmat Summit in New Orleans, so this was an opportunity I saw to submit to send a representative from the local fire departments and LVMPD to attend the summit since in the last year or two with COVID and all that stuff we had not had the opportunity to attend many trainings outside of the valley and this is a good networking opportunity. So this application is to send 1 individual from LVFR, 1 individual from CCFD, North Las Vegas Fire, Mesquite Fire, 1 from LVMPD, and 1 from Henderson Fire; and I don't know if I'm missing anybody to the summit for the week to bring information back to the LEPC and our local hazmat teams on what they've learned and what opportunities are available for us here in the valley.

Chairman Billy Samuels: Jay, so this is Billy Samuels. I do appreciate you bringing this to my attention, I think it was last month you forwarded this over and I think it is a great opportunity for all of our jurisdictions to get together and I do appreciate the fact that it is not just one jurisdiction going to get that knowledge, so I do appreciate that. Does anybody have any questions for Jason or the reason behind it? Go ahead Carolyn.

Carolyn Levering: Jason, is this the same conference that used to be held in Baltimore every June, did they change it to New Orleans?

Jason Moyer: You know, honestly I couldn't tell you. I've never been to a Chemtrek Summit myself. Somebody else might know that answer, but I honestly don't know.

Carolyn Levering: Alright, I'll look into it, thanks.

Chairman Billy Samuels: Hey, Carolyn if you could, Carlito is on military leave right now, I think he would have the answer to that; but I do believe there is something similar to that, but I don't think it's this one.

Carolyn Levering: Yeah, I don't remember Chemtrek being assigned to the Baltimore one, but I know it was an international hazmat conference, but...

Chairman Billy Samuels: Go ahead, whoever spoke first.

Travis Anderson: Yeah, the Baltimore one is different. It's a conference with the ICHIEF's. They're a hazmat conference, but two totally different things.

Carolyn Levering: Thanks for clarifying, Travis.

Karen Taylor: Carolyn just for the record, this is Karen Taylor, we did already get approval to go to ICHIEF's, so that grant has already been approved by SERC.

Carolyn Levering: Thank you, I thought I'd seen something about it, that's why I was a little confused. Thank you for clarifying that.

Chairman Billy Samuels: Thanks Carolyn. Does anybody else have any questions either for Jason or Karen Taylor? I'm hearing no, this is for possible action. I just want to make sure that LEPC does approve this trying to go forward and get those individuals over to New Orleans.

Motion to approve this application by Carolyn Levering.

Carolyn Levering with the First.

Second by Misty Richardson

Billy Samuels: Misty Richardson for the Second. All in favor say "I". Do I hear any opposed. Hearing nothing; the Motion passes. And this was again for the submittal of the 2022 HMEP Mid-Cycle Grant Application in the amount of \$20,608.00 for the LEPC to send 7 individuals to Chemtrek in New Orleans on September 12th to the 14th of 2022. Thanks Jason for bringing it our attention, I do appreciate that. A lot of times we (18:24), so I do appreciate the collaboration we have as this group. Closing out Agenda Item #V, going to open up VI.

VI. Review and Approve the submittal 2022 HMEP Mid-Cycle Grant Application in the amount of \$23,926.00 for LEPC to send 18 individuals to Fire Shows West Conference in Reno on September 26th through the 29th 2022. This is for possible action, Karen Taylor.

Karen Taylor: This is Karen for the record. This is a grant application that we as LEPC have routinely done. The last couple of years obviously this conference has been virtual. This year the plan is to have in attendance at Reno again. The Fire Shows West Conference has many people at LEPC haven't had this. This particular application were requesting 6 people from Clark County Fire, 3 people from Las Vegas Fire, 3 people from Henderson, 2 people from North Las Vegas Fire, 2 people from Mesquite Fire, 1 person from Boulder City Fire and 1 person from Metro.

Chairman Billy Samuels: Thank you, Karen. Does anybody have any questions for Karen on this? I think this is great that we have a Metro representative going to the Fire Shows West. (20:03) applications there for the Fire Department, but I do appreciate Law Enforcement to join us for our parties as well. Again, that's a great Conference and I'm all the jurisdictions are going. Whoever has not gone, it's a great opportunity to go up and do some networking and see what's going on up in the Reno site. It's a good time. This is again for possible action.

Motion to approve by Jeremy Hynds.

Chairman Billy Samuels: Jeremy with the First, thank you. Is that Carolyn or Jason for the Second?

Carolyn Levering: I'll let Jason have it.

Chairman Billy Samuels: Jason Moyer for the Second. He's probably the law enforcement officer that wants to go up there to meet fireman, that's cool. All in favor say "I". Do I hear any opposed? Motion passes for the 2022 HMEP Mid-Cycle Grant Application for \$23,926.00 for LEPC to send 18 individual to Fire Shows West in Reno September 26th through the 29th 2022. Motion passes. That closes Agenda Item #VI, open #VII.

VII. Review and Approve 2023 SERC planning, training and equipment Grant Application for the amount of \$25,000.00 and then \$4,000.00 as administrative, which is totaling \$29,000.00 (21:34) of new working group report. There can be 3 different things on this portion; but A is review application in amount of \$10,560.00 to North Las Vegas to purchase gas mask canisters; B will be review the application in the amount of \$4,644.36 to allow the Las Vegas Metropolitan Police to purchase a freezer; C review application in the amount of \$25,000.00 to allow Clark County Fire Department to purchase atmospheric monitors. This is for possible action.

Chairman Billy Samuels: Karen do you want to go ahead and tackle this. If we need to have each jurisdiction to represent, we can.

Karen Taylor: The SERC announced the SERC (22:15) Grant, is available. It is due back to them by the 23rd of March. That's one of the main purposes of this meeting is to get this application done. I received 3 applications for consideration for this fund. The one portion is \$25,000.00, so as we hear these applications, that portion needs to be \$25,000.00 and then the administrative portion is \$4,000.00. The first application, I will go in order the way I received them is from North Las Vegas and they want to purchase gas masks. Travis are you going to do this, because Solome sent it to me.

Travis Anderson: (23:13) (UNINTELLIGIBLE). I'll get Solome here so she can go over it (23:23) (UNINTELLIGIBLE).

Karen Taylor: Okay, then we'll move on. The next application received was from Las Vegas Metropolitan Police and that was from Jason Moyer. So Jason would like to explain to the group what you want to purchase?

Jason Moyer: Sure. What we're doing is, we're looking to purchase a flammable materials storage evidence freezer for the LVMPD Forensics Lab. The Lab is the only law enforcement agency in Southern Nevada analyzing evidence from the presence of ignitable liquids and/or residues for criminal prosecution purposes for all Southern Nevada law enforcement and fire agencies. The identification of flammable materials obtained from hazardous materials incidents is crucial to investigation, survey, and litigation of hazardous materials incidents at structures, roadways, vehicles and facilities throughout Southern Nevada. Flammable materials need to be stored at low temperatures, required to be stored according to NFPA OSHA Regulations. The current equipment that is being used is actually repurposed WHO Grade freezers that were basically hand-me-downs from the evidence vault, so we're looking into getting them upgraded to properly store any flammable evidence and materials that they

need and get everybody back into NFPA and OSHA Regulations. The amount was \$4,644.00.

Chair Billy Samuels: Hey Jason, this is Billy Samuels. Do you know the temperatures on those commercial size freezers that you have to have?

Jason Moyer: I will defer to Jason Altmeter from our Forensics Lab, he may be able to answer that for us.

Jason Altmeter: I work for the laboratory. Our freezers that we're currently using are a certain door room type freezers. We can get them down to about minus 15 degrees Celsius which is a good temperature to keep anything that may be flammable from evaporating and potentially losing evidence. So those are really the temperatures we're looking at is sub-zero temperatures, but the big thing is to get something that is more explosion proof, more suited for our needs, not a food-grade type freezer. If that answers your question, Chief.

Chairman Billy Samuels: Yes sir it does. (25:57) cold freezers and I don't know what to do with them, so I know that's going to help you guys out. So it's kind of going that route. But I'm not against this, I think it is obviously important and you guys serve all of our communities, so again, I'm not against this, I'm just trying to give you guys more options too.

Karen Taylor: Since I don't hear North Las Vegas on, I will go ahead and do Clark County Fire to the best of my ability. We're requesting \$25,000.00. The request is to purchase 20 atmospheric monitors; 1 calibration kit to calibrate those monitors.

Chairman Billy Samuels: Thanks Karen. Travis did you grab Solome? He went to go get her. So Karen can we just talk about this real quick? I'm looking at it and I'm just doing simple math. This is Billy Samuels. We have \$25,000.00 total; but we're looking close almost \$39,000.00 in projects, correct?

Karen Taylor: That's correct, sir.

Chairman Billy Samuels: Okay we're going to have to do a cut somewhere or someone's not going to get their stuff, right?

Karen Taylor: Correct.

Chairman Billy Samuels: Okay. Are you planning on having that answered during this meeting right now, today, Karen?

Karen Taylor: Yes.

Chairman Billy Samuels: Okay. Let's give Travis a couple of minutes. You guys kind of think about it. Do you have this project in front of you Karen?

Karen Taylor: I do. I can pull it up.

Chairman Billy Samuels: Can you just read it and then Solome can take the rest....oh there she is.

Karen Taylor: The application was for \$10,560.00 and they want to purchase 120 gas mask canisters and that's the only thing on the application was those canisters.

Chairman Billy Samuels: Okay.

Jeremy: (UNINTELLIGIBLE). Canisters are also the masks?

Travis: So I've been talking to Solome. Those are just the canisters to replace the ones that are expired. They are just canisters on the masks.

Chairman Billy Samuels: Copy that. Thank you Travis, thank you Solome. And Jeremy you got your question answered?

Jeremy: Yes I did.

Chairman Billy Samuels: Okay, thank you.

Male Voice: And so the original canisters were purchased on United National Standards, but we're just taking (29:13) and we're just trying to replace them.

Chairman Billy Samuels: Copy that. Well we have about a \$15,000.00 gap is what I'm looking at. Karen, do they have a breakdown of our monitors and how much each one costs?

Karen Taylor: Yes we do.

Chairman Billy Samuels: Can you please break that down for me please?

Karen Taylor: Sure.

Chairman Billy Samuels: Thank you. Obviously the (29:36). So the monitors would be different.

Karen Taylor: The monitors, there are 3 different types of monitors. There are ammonia monitors, and the request was for 9 of them and they are \$575.00; and then there are multi-gas monitors which are similar to what we have purchased before and there are 2 at \$3,090.00; and then there is charcoal monitors 9 of them for \$575.00.

Jeremy: Chief, who is going to be using these monitors on the Clark County Fire site?

Karen Taylor: It's my understanding, Jeremy that these were going to go to the heavy rescue units.

Chairman Billy Samuels: Yeah Jeremy, most car engines and trucks are (30:44) are staffed with some type of gas monitor of some sort, given all of their capabilities. (30:51) just like your (30:56) team works on, they go down into the vault and they have to kind of monitor different levels of gas. So I'm guessing it's the same concept.

Chief Warren Whitney: It's also to support boring company operations should there be an emergency in an unfinished tunnel.

Jeremy: Thanks Chief Whitney. (31:18) since you guys don't have a dedicated hazmat team, how would it be utilized and how is it going to be deployed out to the field and if you guys are only getting 2 multi's, then how would you really push that out; but it makes more sense now and kind of pinpoint it (31:43)

Chief Warren Whitney: Yeah Jeremy, combined (31:45) you have impaired monitoring anytime you go down through a whole through OSHA, and that's not just the hazmat team, that's (31:54) rescue.

Jeremy: Yeah, thanks Chief I appreciate that.

Chairman Billy Samuels: You guys give me a second. I'm going to do some simple math. Well it's not very simple, cause I'm part of the Clark County School District so I'm going to make sure. Karen we can actually take some of our projects off, right?

Karen Taylor: Yeah.

Chairman Billy Samuels: Okay. Metro I'm guess that your freezer is, that's 1 freezer for \$4,600.00?

Jason Moyer: Yes that's correct.

Chairman Billy Samuels: Okay. Chief Anderson, are you able to cut that in half and we'll see if we can cut some of our stuff in half and make sure we can get at least 3 projects through?

Travis Anderson: Assuming, about as much as you need.

Chairman Billy Samuels: Alright, thanks Travis. Let me...Hey Karen what does it look like if we cut North Town's in half and basically cut ours in pretty much half as well? Keep those 2 multi-gas and then supplement the rest of the ammonia and charcoal ones and see where we go from there. Can you do the math real quick for me?

Karen Taylor: Um hmm.

Chairman Billy Samuels: Thank you. So are you guys good with all that, what I'm trying to accomplish?

Male Voice: Hey Chief, I think it's important that we kind of explore what you had talked about with your ultra-freeze freezers. If that's something that you can't use and they can use it instead, push that over to them and just kick that off free-up (33:28) is a lot of this.

Jason Moyer: Yeah and again you know I wish I had more information on what my freezers (33:38). I don't think mine are, what are the words they used....not able to handle the explosive part. I don't know, I just know mine get really cold. I don't know what other characteristics their freezers have, I just don't know. But they're good Dip-N-Dot ones, you can keep Dip-N-Dots in them guys, so if you guys have a party, you guys would be more than happy to use them.

Male Voice: Jason, do you think that that's something that we can look at?

Jason Moyer: I'm mean if it meets the specs, I don't have a problem with it you know for flammability is what they're trying to safely store. I am not familiar with products the Chief has. If we had more time to explore it, I'd be all for it. But then again, I don't want to miss an opportunity here.

Chairman Billy Samuels: Hey Karen, when does this application have to close by?

Karen Taylor: It is due to the SERC on March 23, and I have to take it to the Board of County Commission theoretically before I send it.

Chairman Billy Samuels: Okay. I'm guessing this is of this year, right, not next year?

Karen Taylor: Correct. When I cut ours in half, everything except the calibration equipment, as we're only requesting 1; that brings us down to \$12,200.00.

Chairman Billy Samuels: Okay give me a second, Karen. Thank you for doing that.

Karen Taylor: That would bring us, we're about...we needed to get down to....if we leave Metro whole at the \$4,635.00, and do North Las Vegas at \$5,280.00, then the difference would be \$15,085.00.

Chairman Billy Samuels: I'm sorry, you lost me....so.

Karen Taylor: If we leave Metro whole at \$4,635.00 and cut North Las Vegas in half, that would be \$5,280.00.

Chairman Billy Samuels: So, then we have about \$3,000.00 left, right? We can't count that \$4,000.00, that's administrative.

Karen Taylor: Correct. The administrative we don't count in as part of it; it is part of a separate pot.

Male Voice: Alright so we really only have?

Karen Taylor: The difference would be \$2,885.00 to wiggle with.

Chairman Billy Samuels: Okay. I'm trying to figure out how (39:21) unless you guys. How about let's just make a motion. We'll go that route first and we'll see what you want to do. Go ahead Jeff.

Jeff Ohs: I motion to push forward all 3 applications with the new numbers that were just figured with the potential of excluding the freezer should the Clark County Fire Department freezer fit the need of Metro.

Chairman Billy Samuels: To make sure I'm understanding it correctly that, go through with the numbers, breakdown the ones that we can from North Las Vegas and Clark County's applications, do whatever meets the dollar amount value; and if the freezers that I currently have meets its specs of the Las Vegas Metropolitan Police Department Crime Lab, then we can go forth with upping the numbers of all the additional products.

Jeff Ohs: That is correct. Does that make sense to this group?

Chief Anderson: I follow.

Chairman Billy Samuels: Thanks, Chief. Chief Anderson this is one of your projects and mine as well, are you good with what the intensions are behind this submittal?

Chief Anderson: If we can get 50% paid for through this grant, then that's 50% more than what we had to work by, so we're satisfied with that.

Chairman Billy Samuels: Copy that, thank you Chief. Jason are you good if you guys can come look at the stuff that we currently have which is less than a year old? If they meet the specs of the Crime Lab, would you be willing to hold this application? I'd probably speak to Rachel on this as well, and then we can just do a transfer of assets from what we currently have, if that meets your needs? And if not, continue with your application and Clark County Fire and North Las Vegas would decrease their requests.

Jason: Yes, we'd be willing to take a look at them. We can get it done as soon as possible so everything fits the needs of (41:46), but yes, we'd be willing to look at them.

Chairman Billy Samuels: Copy that, thank you Jason. I'm going to go through my legal counsel, Misty Richardson. Are we able to work to go through to that process that way?

Misty Richardson: (42:08). I'm not seeing a major issue with that, no; as long as it's spelled out exactly as you stated.

Chairman Billy Samuels: Okay.

Karen Taylor: Chief Samuels, this is Karen Taylor for the record. So the \$2,800.00 after each of us pay 50%, we need a decision about that \$2,800.00 whether we're going to cut it in half and I think it would work for both if I cut it in half so it's \$1,600.00 and split it between North Las Vegas and North Las Vegas will be able to get a few more gas masks and I think in our application a couple more things aren't super expensive, so we could increase and get a few more of those items that we removed. I think we can maneuver into it working.

Chairman Billy Samuels: Yes, that's kind of what I was thinking. It also depends on that \$4,600.00; then it would be additional items that North Town and Clark County would just basically split evenly across the board for their 2 products so I think they match equally. But that's kind of my thought process on what it would look like it would work for this item.

Misty Richardson: So whomever made the motion, we should be very clear.

Jason Moyer: I'm good with the wording that Chief Samuels used leaving the numbers at the values that can be calculated to fit the need of all 3 applications.

Misty Richardson: So, this is Misty, that is a challenge, you need very specific numbers. They have to be specifically stated in the motion.

Jason Moyer: Okay, then we'll go with the minimum of the 50% numbers.

Karen Taylor: Well we need to account for the \$2,800.00 Chief, so hold on. So I'm going to go ahead and half the \$2,800.00 and put...I'll give you new numbers for North Las Vegas and us. We can back into it and leave the project for Metro. Is that what you want?

Male Voice: Yes.

Travis: Hey Billy, I was just thinking if they can use your guys' freezer, just take that money that they were going to use and just apply it to no longer use that and just leave us out from that additional finding. So you'll know exactly what you're going to find out after Karen is done and then if they will use the freezer, then just apply it to your guys' grant to buy the additional monitors.

Chairman Billy Samuels: Copy that. That makes sense; thanks Travis, appreciate that.

Karen, did you hear what Chief Anderson just said?

Karen Taylor: Uh huh.

Chairman Billy Samuels: Okay.

Karen Taylor: So that's if Metro is able to use the freezers that we have, then that money would go back to Clark County Fire's application.

Chairman Billy Samuels: While we waiting for Karen to go through this process, I like listening to her multiple calculator with the keys (UNINTELLIGIBLE) right now. Some of you guys might not even know what that is, but a lot of us do.

Karen Taylor: Alright, so the new numbers would be leaving Metro at \$4,635.00; North Las Vegas at \$6,922.00; Clark County Fire at \$11,557.00, which will bring us to the \$25,000.00.

Chairman Billy Samuels: Jeff does that make sense to you?

Karen Taylor: I gave you the wrong number. For Clark County, the number would be \$13,443.00. the other 2 are correct and in your motion then mentioned something about if Las Vegas Metro is able to use Clark County Fire's freezers then their allocation will then be moved to Clark County.

Male Voice: That's the agreement that Chief Samuels and Chief Anderson have, right?

Chairman Billy Samuels: And WP as well.

Male Voice: Okay.

Karen Taylor: Do you need those numbers again?

Travis: Yeah, please just so I can stand correctly.

Karen Taylor: Okay. North Las Vegas \$6,922.00; Las Vegas Metro \$4,635.00; Clark County Fire \$13,443.00.

Chairman Billy Samuels: Karen just so you know, we're going to be off by \$9.00. Metro is \$4,644.00

Karen Taylor: Oh.

Chairman Billy Samuels: So subtract the \$9.00 or whatever from Clark County Fire.

Karen Taylor: So the \$9.00 from ours would be.....

(48:41) (HAD POWER OUTAGE ISSUES) (UNINTELLIGIBLE)

Chairman Billy Samuels: We lost power in our building. For some reason I still have like access, but everybody else that is in this building does not. So we can make a lot of decisions right now without the rest of Clark County Fire knowing anything (LAUGHING). So if we can go forth with that, you guys, the numbers are; Jeff do you want to go ahead and take a shot at that motion?

Motion by Jeff Ohs. So I'll restate the motion to move forward with the 3 applications for North Las Vegas Fire in the amount of \$6,922.00; for Las Vegas Metro PD in the amount of \$4,644.00; and to the Clark County Fire Department in the amount of \$13,434.00.

Chairman Billy Samuels: And I think you just need to make the disclaimer that if LVMPD is able to utilize our freezers, then we will split those funds.

Jeff Ohs: And in the event that Metro is able to use the freezers currently held by Clark County Fire Department that that money will transfer to the 50% agreement between North Las Vegas Fire and Clark County Fire for the purchase of additional equipment as stated in the prior grant application.

Chairman Billy Samuels: That works for me Jeff, thank you. Anybody want to do a second on that?

Angeline Szymanski: I'll Second that.

Chairman Billy Samuels: All in favor say "I". Do I hear any opposed? Thank you group. That motion passes for the amount of \$13,434.00 to CCFD; \$6,922.00 to North Las Vegas; and \$4,644.00 to LVMPD with the caveat that if LVMPD can use the freezer that CCFD holds, we'll do a transfer of assets over to them and that \$4,644.00 will be split evenly between jurisdictions of North Town and CCFD. Closing out Agenda Item #VII. Agenda Item #VIII.
