#### ET-21-400138 (UC-19-0342)-STEELHEAD, GIL LLC:

**USE PERMIT FIRST EXTENSION OF TIME** to establish a Historical Designation (Pioneer Saloon) for a tavern, restaurant, and retail sales and services with accessory uses.

<u>WAIVERS OF DEVELOPMENT STANDARDS</u> for the following: 1) reduced parking lot landscaping; 2) reduce the setback for a non-decorative fence; and 3) increase fence height.

**DESIGN REVIEWS** for the following: 1) food cart/trailer; 2) existing accessory structures (shipping containers, storage building); 3) parking lot redesign; 4) proposed restroom building; and 5) additions

and/or modifications including, but not limited to, an outdoor bar area, outside dining, drinking, and cooking areas, and covered patio areas in conjunction with an existing, restaurant, retail store, and tavern on 1.4 acres in a C-2 (General Commercial) Zone. Generally located on the northwest corner of Spring Street (SR 161) and Fayle Street within Goodsprings. JJ/md/ja (For possible action)

Pioneer Saloon is still listed under Noel Scheckell name because this was submitted prior to final of selling. Stephanie Richter and Stephen Staats representing asked for 18 month extension for changes to get done thourally. Tuesday's is 50% discount for food and merchandise for Goodsprings locals, 10% other days. Board recommended 2 year extension.

**<u>USE PERMITS</u>** for the following: 1) expansion of a recreational facility; 2) major training facility; 3) camping in conjunction with a recreational facility; 4) a heliport.

<u>WAIVERS OF DEVELOPMENT STANDARDS</u> for the following: 1)expansion of a recreational facility; 2) a major training facility; 3) camping cabins and accessory structures; and 4) a grading plan in conjunction with a hillside development (slopes greater than 12%) on a portion of 375.3 acres in an R-U (Rural Open Land) Zone. Generally located 2.2 miles west of Kingston Road, 1.3 miles north of Sandy Valley Road within Goodsprings. JJ/nr/jo (For possible action)
