## **STATUTES**

The Nevada laws (NRS) on any topic may be researched online at:

To search the laws by topic, click on the letter of the alphabet at the top of the page and scroll down to your topic of choice to see all the laws associated with that topic. Click on the blue link(s) next to the topic to read the actual laws. Annotated print sets of the Nevada laws are also available in person at the Law Library and include additional information such as cases and attorney general opinions.

## **DATABASES**

Further cases may be researched in person at the Law Library utilizing our legal research databases such as **Westlaw**, **Lexis Advance** or **Trellis**.

Nevada does not have one standardized set of official court forms, so it is not unusual to have to create your own forms using sample language and formatting requirements.
