**AN ORDINANCE TO AMEND TITLE 13, CHAPTER 13.04 OF THE CLARK COUNTY CODE, TO ADD SUBSECTION 106.6.1.1 RESUBMITTAL FEES AND SUBSECTION 106.6.1.2 REVISION FEES TO SECTION 13.04.070 SCOPE AND ADMINISTRATION TO DEFINE LANGUAGE AS DESCRIBED IN SECTION 106.6, PERMIT & FEE SERVICE SCHEDULE, TABLE 106-G.**

**THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CLARK, STATE OF NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:**

SECTION 1. Title 13.04 of the Clark County Code is amended and adopted to read as follows:

**13.04.070 Scope and Administration.** A subsection, designated “106.6.1.1 Resubmittal Fees” is added to read as follows:

106.6.1.1 Resubmittal Fees. The permit fee includes the initial plan review and one (1) subsequent plan review for any necessary corrections. Any additional plan reviews required will be charged hourly, in accordance with the rate for “Additional plan review fees” as described in Section 106.6, Table 106-G. These additional plan review fees shall be due and collected at the completion of the plan review, prior to the issuance of the permit.

**13.04.070 Scope and Administration.** A subsection, designated “106.6.1.2 Revision Fees” is added to read as follows:

106.6.1.2 Revision Fees. Revision fees for review of changes to previously approved plans shall be charged at the hourly rate for “Additional plan review fees” as described in Section 106.6, Permit & Fee Service Schedule, Table 106-G. These additional plan review fees shall be due and collected at the completion of the plan review, prior to the issuance of the permit.

SECTION 2. If any section of this ordinance or portion thereof is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not invalidate the remaining parts of this ordinance.

SECTION 3. All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases or sentences contained in the Clark County Code in conflict herewith are hereby repealed.

SECTION 4. This ordinance shall be published thereof by title only, together with the names of the County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Clark County, Nevada, at least once a week for a period of two (2) weeks and shall be effective on and from the fifteenth day after passage.
