

**Clark County Public Art Committee Meeting
August 23, 2016 at 3:30 pm
Winchester Cultural Center**

I. MEETING OPENING: Michael Ogilvie opened the meeting. In attendance: committee members – Keith Conley, Vicki Richardson, Louisa McDonald and Rebecca Holden. Excused: Eric Strain, Patty Dominguez and Robert Fielden. Staff: Michael Ogilvie and Julie Navis.

II. MINUTES - **Keith moved to approve July 26, 2016 minutes, Vicki seconded. The motion passed unanimously.**

III. APPROVAL OF AGENDA - **Keith moved to approve agenda, Rebecca seconded. The motion passed unanimously.**

IV. West Flamingo Senior Center – presentation from Diane Bush – *For Discussion and possible action*

Diane Bush could not make it to the meeting for the presentation. Michael said we could save this until the next meeting. Michael showed photos of the potential areas around the building. No action was taken and this has been tabled until the next meeting.

V. Centered 2 – *For Discussion and possible action*

Michael announced that the K.D. Matheson piece from Centered 1 was installed and also vandalized shortly after. The crack in the sculpture is at the base, which can be fixed on site. Louisa suggested installing and investigating surveillance at some of our public art pieces that may be vulnerable. Michael said he would look into it. Michael suggested doing Centered 2 down Pecos because the County owns Pecos. Michael said he doesn't have a forecasted budget yet for 2018. Keith asked what the budget was for Centered 1. Michael said \$175,000. Louisa asked what would be the advantage of limiting it to one street. Michael said it was mentioned by Eric and he's not sure what he was thinking what the advantage would be. Michael said personally he thinks it could be like a singular road gallery. Vicki thinks before we vote on Centered 2 that we should evaluate Centered 1 first and see how it has been received by the public. Also, it would be good to look at spots that already have cameras in place since current centered pieces are being vandalized. Michael agrees with Vicki on calculating the public's response and the political response to this. The committee members agreed that they should have a map of the County to see where the can put projects. Keith suggested getting a big board with a map printed on it. Keith said with the Centered 2 project placing them around the County in outlying areas should be considered. Rebecca asked if these were permanent or temporary. Michael said there was a discussion to make them temporary in the initial planning stages, but the final decision made by the committee was to make them permanent. No action was taken and the committee decided to table this for the next meeting.
