- V. Budget Presentations (*not an action item*)
  - a. West Flamingo Indoor Pool Ceramic Mural – Proposal is to create a ceramic tile mural in the indoor pool area. The artist(s) will work with adults 55+, then create a digital design that integrates ideas learned by the community. The printing and installation of the artwork will be managed by county staff. Proposed budget of \$20,000.
  - b. Von Tobel Modular Building Vinyl Wrap – Proposal is to create a vinyl mural on the exterior surface of the community center at Von Tobel Park. The artist(s) will work with children, then create a digital design that integrates ideas learned by the community. The printing and installation of the artwork will be managed by county staff. Proposed budget of \$60,000.
  - c. Zap 13 – Project is to paint utility boxes in District F. Presentation on the history of Zap. Proposed budget of \$25,000.
