- I. Call to Order

- II. Public Comments: None
- III. Minutes - **Bonin-Pissarro moved to approve the November 26th minutes, McCurdy seconded. The Motion passed unanimously.**
- IV. Agenda – **Fulmer moved to approve agenda, Bradford seconded. The motion passed unanimously.**
- V. Review of Budget Presentation and FY21 Budget Protocols – Mickey described how the process will proceed. Stake holders will present for around 10 minutes with 5-15 minutes of questions about the project. A final decision will be made in April with artists not being present. Staff will recommend pricing using best standards and practices. Art committee will make a decision on funding in April.
- VI. Budget Presentations (*not an action item*)
  - a. Mobile Art Carts for Rent – Mickey presented a power point presentation. Artists would be required to go through a training course. This would help them develop a business, create a business plan and successfully start their own business.  
  
Parks & Recreation Special Events could hold a festival to promote the carts and help spread awareness of them. Carts would be open to all arts including visual  
  
Clark County would not own the carts but could possibly help maintain a website.  
  
Questions were presented about who would provide the training. Mickey will be meeting with County Director of Economic Growth and Development as well as coalition that offers training to help small businesses thrive through Clark County Library.
- VII. Review of Marketing Efforts –  
  
Mickey provided a handout that detailed engagements on social media and the county Public Arts website. The department will be using both print and radio ads to get the word out on upcoming events such as the Impact exhibit. Commercials will also alternate to get people involved in full scope.
