5. Assign Jury Members to existing calls - One board member will be assigned to represent the Art Committee on the jury for the following public art project; (*for possible action*)
  - a. Zap at the Stadium.  
**Committee motioned for Jerry Schefcik to be assigned to Zap at the Stadium Public Art Project.**

6. Budget Presentations- to allocate \$548,000 to new budgets (*for possible action*).

- a. Stadium District Mural in District A – Proposal is to paint a mural on the utility boxes under the overpass and the walls of the overpass that faces the I-15 and the tailgate area of the stadium. Proposed budget: \$112,040.  
  - **Suggestion for a tile or another installation instead of a mural and to extend artwork to all walls.**
  - **Committee leaning towards increasing funds for this project.**
- b. Nellis Meadows Conex Mural in District B – Proposal is to create a mural on the exterior of the Conex box located within the park. Proposed budget: \$5,625  
  - **Funding may increase depending on what experience is expected of the artist.**
- c. Lee Canyon Meadow Sculpture in District C – Proposal is to create a sculpture within the Meadows with a historical theme. Proposed budget: \$50,000.  
  - **There were some concerns about the budget being too small for the scope and about cultural appropriation.**
  - **To accommodate the budget, a suggestion was made to create smaller sculpture or smaller art installation pieces.**
- d. Walnut Recreation Center Gym Mural in District D – Proposal is to paint a mural on the existing tile in the gym. Proposed budget: \$21,157.  
  - **Suggestion to paint the mural on a different wall located on the outside of Walnut Recreation Center instead of the gym.**
- e. Hollywood Recreation Center Blvd Mural District E – Proposal is to paint a mural on the recreation center building facing the Blvd. Proposed budget: \$46,480.  
  - **Committee leaning towards painting the 44 x 22 and 36 x 10 walls on the outside of the Hollywood recreation center.**
- f. Aquatic Springs Lobby Mural in District F – Proposal is to create a mural using sound board technology within the lobby of Aquatic Springs Facility over 30% of the wall space. Proposed budget: \$50,000.  
  - **Proposal language to be adjusted to be vaguer.**
- g. Silver Bowl Art in the park in District G – Proposal is to create artwork within the park. Proposed budget: \$262,698.
