Clark County Aquatic Springs Rental Guidelines

Please initial each section and sign your name below indicating your willingness to abide by the rules governing Clark County Aquatic Facility Rentals. Failure to adhere to the following guidelines may cause the rental to be terminated without refund.

- The person who originates the rental must be at least 21 years of age and remain in the building for the entire length of the rental. _____
- All groups must review all rules with their participants, follow the posted pool rules, and obey all instructions by County staff members. Failure to do so will result in cancellation of future usage, and/or removal from the facility without a refund. _____
- **Renter must adhere to the reserved times of their rental. Additional time will not be granted the day of the rental. Reserved times must include set-up and clean-up time.** _____
- No fees or concessions may be charged. _____
- County facilities may not be used for the purpose of direct or indirect financial gain. _____
- Cleaning the facility and disposing of trash is the responsibility of the renter. Trash should be bagged up and ready to be taken to the dumpster. Insufficient cleaning will result in additional charges for cleaning. _____
- Children attending the event are the renter's responsibility and must be supervised at all times. In the event of unruly behavior associated with your group, the renters will receive one warning to control the group. If the behavior continues, Park Police or Metro will be contacted, and the rental may be terminated. _____
- County tables and chairs may be used but must be returned clean and to their original positions. _____
- Alcoholic beverages and glass bottles are not allowed. Smoking, vaping and/or illegal drugs are not permitted on the premises. _____
- Food and drink are only allowed in the classroom, not on the pool deck. _____
- All children under 8 must always have an adult in the water within arm's reach, unless they pass a water competency test. _____
- To use the amenities (Obstacle course with large slide/ Rock climbing wall), participants under 18 must pass a water competency test and have their waiver signed by a parent/guardian. _____
- Amenities cannot be added after the initial reservation is made due to additional staffing costs that must be prearranged. _____
- Rentals may be cancelled due to lightning/inclement weather or pool equipment failures. In this case, the rental may be moved to another date, or the customer will be refunded for time lost. _____

Refund Policy

The group agrees to assume the risk of using the reserved pool area, and hold harmless and indemnify Clark County from and against any and all claims, demands, obligations, causes of action and lawsuits, and all damages, liabilities, fines, judgments and costs (including reasonable attorney's fees) associated with, arising from or alleged to have risen from the actions or omissions of the group, its agents, employees or contractors, in connection with the event, or its failure to comply with the laws, ordinances, rules and regulations applicable to its duties and responsibilities set forth herein. We also understand that the group is responsible for repair and/or clean-up costs incurred by Clark County if the reserved area is damaged or vandalized as a result of this reserved use and agree to reimburse Clark County for any such expenses. Clark County reserves the right to revoke this reservation should any information herein be found to be inaccurate or untrue.
