Clark County's 1 October Memorial Committee will meet at **9 a.m.** on **Wednesday, Jan. 27**, using a virtual format due to current COVID-19 health and safety practices that are in place. The Clark County Government Center is closed to the public in addition to most County buildings to help reduce the spread of COVID-19 in accordance with the governor's emergency directives.

The Jan. 27 meeting will include a presentation by Harriet F. Senie, an author and art history professor, entitled: "Memorial Options: Figures, Walls, Museum, Gardens or?"

Anyone impacted by the 1 October attack is invited to participate in the process of developing a memorial whether you live in the Las Vegas Valley or outside our community. Committee meetings are held at 9 a.m. on the fourth Wednesday of each month. The public is encouraged to visit the committee's website page to join its email list to receive updates about the committee's activities and information about upcoming surveys and other special opportunities to offer ideas and input. The Clark County Commission appointed the seven-member 1 October Memorial Committee to gather input from the public and develop recommendations for a permanent memorial in the Las Vegas Valley. The committee began meeting in October 2020. The County's goal is to create a memorial that remembers those who perished in the events of 1 October 2017, honors the survivors, first responders and everyday heroes who inspired the nation with their bravery, and celebrates the resiliency and compassion of our community.

Members of the 1 October Memorial Committee include: Tennille Pereira, director of the County's Vegas Strong Resiliency Center, serving as Chairman; Karessa Royce, a 1 October survivor, serving as Vice Chairman; Mynda Smith, the sister of 1 October Victim Neysa Tonks; Andrew Walsh, a deputy chief for the Las Vegas Metropolitan Police Department who responded to the scene of the 1 October attack; architect Dr. Robert Fielden, who established the UNLV School of Architecture; Rebecca Holden, public art project manager for the city of Las Vegas Office of Cultural Affairs; and Harold Bradford, a local artist and sign industry designer. Punam Mathur, a well-respected community leader and consultant, will facilitate committee meetings, while staff from Clark County's Parks and Recreation Department and other departments will support the group's activities.
